DIRECTIONS

Leave Derby City Centre along Kedleston Road and turn left onto Cowley Street, continue straight on to Mackworth Road, passing the Markeaton recreation ground and turn left onto Markeaton Street. Markeaton Court is on the right hand side where the property is clearly identified by our "to let" board.

Markeaton Court is an exclusive development of eight individual properties which were completed in 2015 and finished to the highest specification. Each of the properties benefits from the very latest construction techniques and include double glazing and gas central heating. Each is property is further complimented by one allocated car parking space.

Markeaton Court is a short walk from the vibrant City Centre of Derby with its wealth of shops, restaurants and the Intu shopping centre. The property is within a short walk of Markeaton Park, Darley Park, Derby University and the Royal School for the Deaf and is brilliantly situated for ease of access to the ring road and A38.

OPEN PLAN LIVING AREA / DINING

20'2 x 13'5 (6.15m x 4.09m)
This large and versatile space has four double glazed windows overlooking the front elevation and there is an open plan space which is set aside for living room furniture as well as kitchen space. The kitchen has a range of work surfacing preparation areas, wall and base cupboards, integrated electric, gas hob and shaped extractor over. The kitchen has a stainless steel sink unit with drainer and there is space for a washing machine, space for an enclosed fridge freezer, two radiators

GROUND FLOOR CLOAKROOM

With low level WC, pedestal wash hand basin with tiled splashback, extractor fan, useful under stairs storage cupboard and radiator.

TO THE FIRST FLOOR

LANDING

With double glazed window, over stairs storage cupboard.

BEDROOM ONE

12'7 x 9' plus recess (3.84m x 2.74m plus recess)
With double glazed window to the front elevation overlooking the Markeaton Bowling Green and radiator.

BEDROOM TWO

8'8 x 10'6 (2.64m x 3.20m)
With double glazed window and radiator.

BATHROOM

10'3 x 6'1 (3.12m x 1.85m)
With low level WC, pedestal wash hand basin and bath with electric shower over. The bathroom benefits from inset ceiling spotlights to the ceiling, extractor fan and heated towel rail.

OUTSIDE

The property benefits from managed communal gardens and one allocated car parking space.

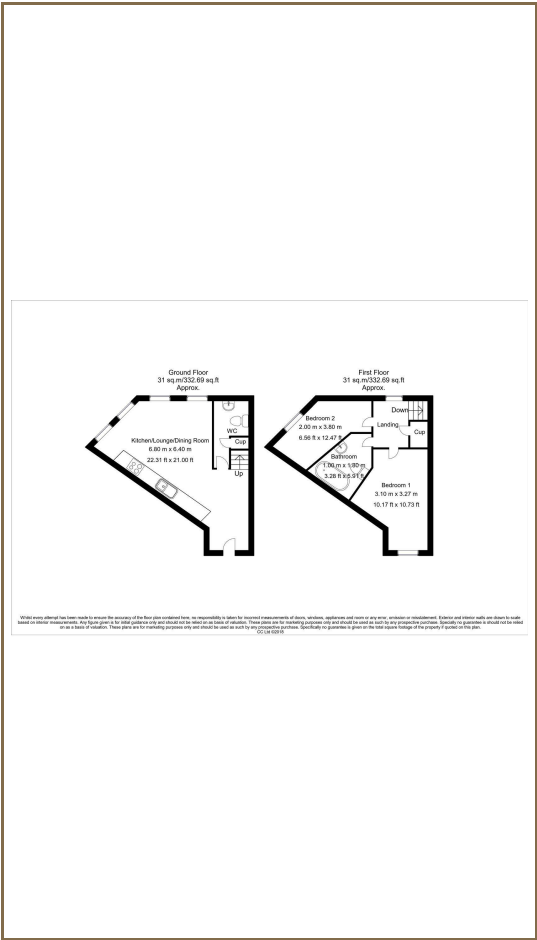

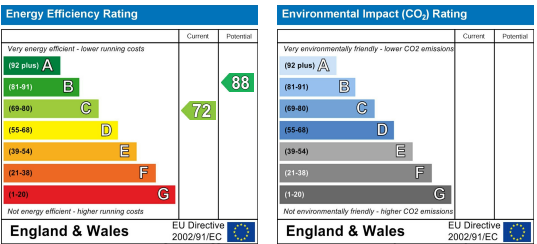
Area Map
