- Shared FREE laundry facilities.

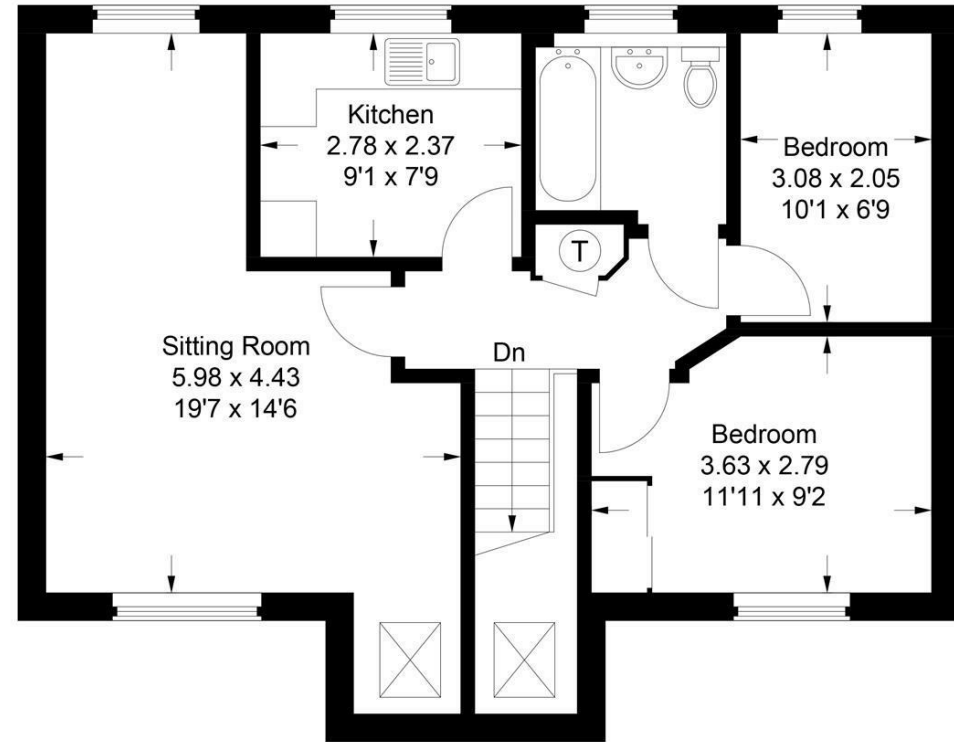
