1. Information and Scope of Inspection

	Access to the main roof space is via a ceiling hatch located off the landing. This roof frame is unfloored with insulation materials laid between and over ceiling joists and accommodates redundant cold water storage tanks. Some thin polystyrene sheeting encapsulated in plastic has been installed between rafters.

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We assume that the carriageways etc., ex adverso the subjects are the responsibility of the Local Authority.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the installation of patio doors to the rear elevation, the apparent removal of a wall at ground floor level within the living/dining room and the relocation of the kitchen entry point from the hallway to the living/dining room. In addition, double glazed window units and doors have been installed within the property.

Estimated Reinstatement Cost for Insurance Purposes

£275,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £275,000 (TWO HUNDRED AND SEVENTY-FIVE THOUSAND POUNDS STERLING).

Valuation and Market Comments

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £200,000 (TWO HUNDRED THOUSAND POUNDS STERLING).

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. 

The energy efficiency rating of your home
