#### 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

#### **Roofing including Roof Space**

The roof is timber pitched and overlaid with tiles.

Access to the roof space is via a ceiling hatch located off the landing. The roof frame has had partial raised flooring installed. Insulation materials have been laid between and over ceiling joists with further thin insulation having been installed between rafters. The roof space accommodates a cement flue pipe.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

#### **Rainwater Fittings**

PVC design.

Visually inspected with the aid of binoculars where appropriate.

#### **Main Walls**

The main walls are of traditional cavity brick/block construction with a mixture of rendered and pointed facing brick features. Cavity wall insulation has been installed.

There is a section of timber framed cavity infill to the rear elevation where a former rear door opening has been removed.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and Joinery	Window units are of mixed age replacement uPVC double glazed design. The property is accessed to the front by a composite part double glazed door with a uPVC double glazed side insert panel. There are uPVC double glazed French doors installed within the rear elevation. Eaves areas appear to be formed in a mixture of timber and cement sheet materials.  Internal and external doors were opened and closed where keys were available.  Random windows were opened and closed where possible.  Doors and windows were not forced open.
External Decorations	External decorations are of painted and uPVC finishes.  Visually inspected.
Conservatories / Porches	Not applicable.
Communal Areas	Not applicable.
Garages and Permanent Outbuildings	There is a sizeable single detached concrete sectional garage to the rear of the property, this beneath a flat, felt-clad roof. This is accessed to the front by a metal up and over door and to the side by a further timber pedestrian door. There is no vehicular access to the garage at present as this is screened off from the driveway by timber fencing.  Visually inspected.
Outside Areas and Boundaries	There are private front, side and rear garden grounds incorporating a paved driveway to the side. Boundaries are part open and formed thereafter by low blockwork walling, conifer or similar style hedging and timber fencing.  Visually inspected.
Ceilings	Ceilings are plasterboard lined.

#### Internal Walls Internal walls are plastered and plasterboard lined. Visually inspected from floor level. Using a moisture meter, walls were randomly tested for dampness where considered appropriate. Floors Including Sub-Floors Flooring at entry level is of solid concrete construction being of suspended timber construction thereafter. Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted. Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point. Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch. **Internal Joinery and Kitchen** Internal joinery is of timber with timber internal pass doors, door facings **Fittings** and skirtings. Double leaf timber doors between the kitchen and living room have glazed inserts. There is a timber framed staircase. The kitchen is fitted with floor and wall mounted storage units. Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances. **Chimney Breasts and Fireplaces** There is no apparent chimney breast, however, there is a cement flue pipe in the roof space connecting to a vented ridge tile. Visually inspected. No testing of the flues or fittings was carried out. **Internal Decorations** Internal decoration is a mixture of papered, painted, textured, decorative lined and tiled finishes.

Visually inspected.

#### Cellars Not applicable.

#### **Electricity**

Mains supply. The electrical switch gear is located within the under stair cupboard. The electricity meter is wall mounted within a shallow cupboard at the gable.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

#### Gas

Mains supply. The gas meter is located within the hallway cupboard.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

### Water, Plumbing and Bathroom Fittings

Mains water supply. Where seen, plumber work is formed in PVC and copper materials. The stopcock appears to be located beneath the kitchen sink. The bathroom comprises a three piece suite with thermostatic valve shower over the bath.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

## Heating and Hot Water There is a wall mounted gas fired combination central heating boiler located within the kitchen. This supplies steel panelled radiators and also provides domestic hot water. There is a heated towel rail within the bathroom. Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage	All foul and surface water drainage is assumed to be connected to the main public sewer.
	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms	New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to Inspection**

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

A restricted inspection was possible only of the roof space due to accessibility, insulation materials and/or storage items.

Our inspection was restricted to the exposed and accessible surface fabric.

Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.

Restricted inspection in cupboards due to storage items.

The inspection of the garage was restricted due to site access constraints, the positioning of boundaries and the presence of stored items therein.

At the time of inspection, the subjects were occupied, furnished and floors throughout were covered.

A restricted inspection was possible only of the roof from ground level.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

	The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.
	A cement flue passing through the roof space may contain encapsulated asbestos fibres within its construction. The current informed view is that if left undisturbed this will present no significant hazard to health. However some potential purchasers may be deterred by its presence and in the event of damage or disturbance significant costs should be anticipated in respect of removal and handling.

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.

	Main Walls
Repair Category	2
Notes	There is a degree of weathering to the main walls including deterioration to basecourse areas, exposing some underlying masonry. There is localised cracked render. Some deterioration was noted to external tiled window sills. The need for ongoing maintenance/repair should be anticipated.

	Windows, External Doors and Joinery
Repair Category	2

Notes	Older style replacement window units within the property are showing some signs of deterioration including stiff handles and opening mechanisms. Failed double glazed window unit seals were noted causing condensation to form between the panes.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.
	The front door requires adjustment.
	Some staining and weathered/flaking decorations were noted to eaves.

Notes	The external decorations are generally in fair order. Regular repainting will be required if these areas are to be maintained in satisfactory condition.

Notes	The garage is showing general signs of deterioration with weathering and some staining noted to the felt roof. The side access door lock is difficult to operate. There is deterioration to external timbers.
	Some materials within the garage may contain encapsulated asbestos fibres within their construction. The current informed view is that if left undisturbed this will present no significant hazard to health. However some potential purchasers may be deterred by its presence and in the event of damage or disturbance significant costs should be anticipated in respect of removal and handling.

Notes	The boundaries appear reasonably well defined and are in adequate condition.  Regular maintenance will be required. You should verify with your conveyancer the extent of the boundaries attaching to the property.  There is some localised wear to fencing.

Notes	There are some sections of loose and creaking flooring.  Older style linoleum floor tiling within the under stair cupboard may contain encapsulated asbestos fibres within its construction. Further specialist advice should be sought prior to handling/removing such materials.

Notes	The kitchen units are of a modern type and are in good condition.  The internal joinery is generally in keeping with the age and type of property and appeared in fair condition consistent with age.

#### 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We assume that the carriageways etc., ex adverso the subjects are the responsibility of the Local Authority.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the installation of replacement double glazed window units and doors together with the installation of French doors in place of a former window to the rear of the property. Further alterations have been undertaken to remove and partly in-fill a former rear door opening from the kitchen and to replace the kitchen window.

#### **Estimated Reinstatement Cost for Insurance Purposes**

£225,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £225,000 (TWO HUNDRED AND TWENTY-FIVE THOUSAND POUNDS STERLING).

#### **Valuation and Market Comments**

£185,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £185,000 (ONE HUNDRED AND EIGHTY-FIVE THOUSAND POUNDS STERLING).

#### TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.



The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 




#### **Energy Efficiency Rating**

#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

#### The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 39 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 2.7 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.5 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.



#### About the recommended measures to improve your home's performance rating

#### 1 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

#### 2 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 3 Replacement glazing units

Replacing existing double-glazed units with new high-performance units. Building regulations require that replacement glazing is to a standard no worse than previous; a building warrant is not required. Planning permission might be required for such work if a building is listed or within a conservation area so it is best to check with your local authority.

#### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). #### Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
