#### 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

Detached 1 ½ storey property.

Accommodation

Ground Floor – Entrance Porch / Utility Room, Hallway, Study, Kitchen, Two Sitting Rooms, Shower Room and Bedroom.

First Floor – Landing, Bathroom and Two Bedrooms.

Gross internal floor area (m²)

147m<sup>2</sup>.

Neighbourhood and location

Situated close to the village of St Margarets Hope on the rural island of South Ronaldsay, the fourth of four islands linked to the Orkney Mainland by a series of four causeways, each two way road width.

Age

Original c.1800's with extensive renovation and dormer added c.2015.
Rear extension c.1980's with dormer added c.2015.
Front extension c.2015.

Weather

Dull and windy with rain showers.

Chimney stacks

Visually inspected with the aid of binoculars where appropriate.

Two stone chimney stacks, rendered, with coping and one pot to each.

Visible leadwork where passing through the roof.

# Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Main pitched roof clad concrete tiles – no inspection to underside of main roof or timbers.

Rear extension pitched roof clad concrete tiles on plywood sarking and timber trusses, where open to inspection. Very restricted inspection access to rear extension roof space and timbers from a small eaves hatch.

Front extension pitched roof clad concrete tiles – no inspection to underside of front extension roof or timbers.

Main section dormer window with lead finish to flat roof and side walls – no inspection access to main section dormer flat roof timbers.

Rear extension dormer window with pitched roof clad concrete tiles – no inspection access to rear extension dormer roof space or timbers.

Front extension dormer window with pitched roof clad concrete tiles – no inspection access to front extension dormer roof space or timbers.

### **Rainwater fittings**

Visually inspected with the aid of binoculars where appropriate.

P.V.C gutters and downpipes.

#### Main walls

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Main stone walls, rendered.

Rear extension appears to be of concrete block cavity construction, rendered.

Front extension of timber frame construction externally clad timber weatherboarding.

# Windows, external doors and joinery

External doors were opened and closed where keys were available.

Random windows were opened and closed where possible. Doors and windows were not forced open.

Windows are a combination of double glazed and triple glazed timber with double glazed Velux windows to first floor.

Single glazed timber window between study and entrance porch / utility.

Triple glazed timber external doors.

Triple glazed windows and doors are externally clad aluminium.

#### **External decorations**

Visually inspected.

Paint finish to rendered walls, sills, ingos and chimney stacks.

Timber treatment to external joinery.

# Conservatories / porches

Visually inspected.

Rear entrance porch / utility with stone walls and timber weatherboarding to upper side wall, monopitched roof with what appears to be a rubber finish and two sky lights.

No inspection access to rear entrance porch / utility roof timbers.

#### Communal areas

Visually inspected.

Long unsurfaced access track with cattle grid.

Ownership, rights of access and maintenance responsibilities for the access track should be confirmed.

# Garages and permanent outbuildings

Visually inspected.

Detached stone outbuilding / workshop which has been internally lined plasterboard with pitched roof clad natural slate, double glazed u.P.V.C window and external door and double glazed Velux windows. No inspection access to the underside of the roof due to the internal linings.

Detached stone outbuilding / garage with pitched corrugated fibre cement (may contain asbestos) sheeted roof, double glazed u.P.V.C window and door. Rear section has been lined with plywood.

Concrete block shed with felt roof. Timber shed with profile sheeted roof. Polycrub.

# Outside areas and boundaries

Visually inspected.

Site is understood to extend to approximately 3.5 acres – this should be confirmed.

Stone chipped driveway.

Concrete and gravel pathways.

Agricultural style post and wire boundary fencing, where inspected – not all boundaries inspected due to site area.

### Ceilings

Visually inspected from floor level.

Ceilings are lined either plasterboard or timber panels.

#### Internal walls

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Internal walls and partitions are lined either plasterboard or timber panels.

As per Seller, the original section internal walls have been internally insulated as part of the renovation works.

# Floors including sub floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Solid ground floor and suspended timber first floor.

# Internal joinery and kitchen fittings

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Internal doors are either timber panelled or glazed panelled.

Timber staircase, facings and skirtings. Built in units to kitchen and utility room.

# Chimney breasts and fireplaces

Visually inspected. No testing of the flues or fittings was carried out.

Chimney breast to sitting room lined plasterboard with stone hearth and solid fuel stove. No open fireplaces.

#### Internal decorations

Visually inspected.

Ceilings and walls are finished emulsion to plasterboard and paint to timber panels.

Textured finish to study ceiling.

Varnish or paint finish to internal joinery.

#### **Cellars**

Visually inspected.

None.

#### **Electricity**

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains electricity supply.

5kw wind turbine, as per Seller – ownership of the wind turbine and details of any Feed in Tariff should be confirmed.

#### Gas

Visually inspected.

No mains gas in Orkney.

# Water, plumbing and bathroom fittings

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

Mains water supply.

Shower Room – mixer shower cubicle, wash hand basin and W.C.

Bathroom – bath with mixer shower over, wash hand basin and W.C.

Ceramic kitchen sink with drainer.

Stainless steel sink with drainer to utility room.

# Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

Air to water heat pump with underfloor heating to majority of ground floor and radiators to ground floor bedroom and first floor.

Solid fuel stove to sitting room.

Heated towel rail to shower room and bathroom.

Insulated hot water cylinder.

#### **Drainage**

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Private septic tank – location should be confirmed.

# Fire, smoke and burglar alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

Smoke detector to sitting room and landing. High heat detector to hallway and kitchen.

IMPORTANT **NOTE:** Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detecting alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon-fuelled appliance e.g. central heating boiler, open fire, wood burning stove etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriately accredited contractors to ensure compliance.

### Any additional limits to inspection:


There was no access for inspection to the foundations, to behind side wall linings, to timber side walls or to the underside of the main floor construction. The property was fully furnished at the time of inspection. Fitted coverings prevented access to the floor surfaces. No inspection to main roof timbers, main roof dormer flat roof timbers, rear extension dormer roof space or timbers, front extension roof timbers or front extension dormer roof space or timbers. Very restricted inspection access to rear extension roof space or timbers from a small eaves hatch. Not all boundaries were inspected due to site area. The condition or efficiency of the heating and drainage systems cannot be commented upon.

Tests by the Health Protection Agency have identified some properties in Orkney as having natural levels of Radon Gas in excess of those normally considered acceptable. Further advice on this should be obtained from the Health Protection Agency. Telephone 01235 822745/876/737.

An inspection for Japanese Knotweed or other invasive plant species was not carried out and unless otherwise stated, for the purposes of this report, it is assumed that there is no Japanese Knotweed or other invasive plant species within the boundaries of the property or in neighbouring properties.

It is out with the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

#### SINGLE SURVEY TERMS AND CONDITIONS (WITH MVR)

#### **PART 1 - GENERAL**

#### 1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report and a generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

The Surveyors are authorised to provide a transcript or retype of the generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by Brokers and Lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the generic Mortgage Valuation Report and the Single Survey. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors require to amend the valuation in consequence of such information, they will issue an amended Report and generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon Residential Property. 1

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's Agent or relative to the property, they will be obliged to indicate this by ticking the adjacent box.

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 THE REPORT

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

All intellectual property rights whatsoever (including copyright) in and to the Report, excluding the headings and rubrics, are the exclusive property of the Surveyors and shall remain their exclusive property unless they assign the same to any other party in writing.

#### 1.7 PAYMENT

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid.

Additional fees will be charged for subsequent inspections and Reports.

#### 1.8 CANCELLATION

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. #### **PART 2 – DESCRIPTION OF THE REPORT**

#### 2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a

duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any other minor defects.

Throughout the Report, the following repair categories will be used to give an overall opinion of the state of repair and condition of the property.





### The energy efficiency rating of your home



### About the recommended measures to improve your home's performance rating

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The heating system controls should be improved so that both the temperature and time of heating can be set differently in separate areas of your house; this will reduce the amount of energy used and lower fuel bills. For example, it is possible to have cooler temperatures in the bedrooms than in the living room provided internal doors are kept closed, and to have a longer heating period for the living room. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### Low and zero carbon energy sources
