1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

Description

Eastbank comprises an original cottage with three storey extension to the rear and an attached garage. The property includes a total of 4.38 acres.

Accommodation

Original Cottage - Ground Floor: Sitting Room, Kitchen/Dining Room, Bedroom, Bathroom, Vestibule, Hall.

Extension – Ground Floor: Sitting Room, Kitchen/Dining Room, Entrance Vestibule.

Extension – First Floor: Bedroom, Shower Room, Open mezzanine area.

Extension – Second Floor: Bedroom/Mezzanine.

Gross internal floor area (m²)

The gross internal floor area of the property is approximately 293m2.

Neighbourhood and location

The property is situated in a rural location in Orkney. All the usual amenities are available in Stromness and Kirkwall.

Orkney is well connected to mainland Scotland with regular sea and air services.



Age

The age of the original cottage is not known, but is likely to

be around 100 years old.

It is understood that the extension was added in 1995,

with the cottage renovated at the same time.

Weather

The weather was cool with showers, following a period of changeable weather. The report should be read in context of these weather conditions.

Chimney stacks

Stone built chimney stacks to both gables of the original cottage.

Both stacks are rendered, with concrete copes and single clay chimney cans.

Visually inspected with the aid of binoculars where appropriate.

Roofing including roof space

Pitched timber framed roof structures.

Slate effect tiles to the original cottage; fibre cement slates to the extension.

Accessible roof space to the original cottage; timber sarking boards and fibreglass insulation to the ceiling joists.

The ceiling linings to the extension are fitted at rafter level.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Rainwater fittings

uPVC gutters and downpipes.

Visually inspected with the aid of binoculars where appropriate.

Main walls

External walls to the original cottage are stone built; assumed concrete cavity block-work to the extension, with a steel structural frame.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected

Windows, external doors and joinery

uPVC double glazed windows and external doors. Timber fascia boards.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible. Doors and windows were not forced open.



External decorations

The timber fascia boards are painted.

Visually inspected.

Conservatories / porches

There are Entrance Porches to the front elevation of the Cottage, and forming the link between the cottage and extension.

Visually inspected.

Communal areas

There are no communal areas.

Circulation areas visually inspected.

Garages and permanent outbuildings

There is a garage attached to the southern gable of the Cottage, consisting of a concrete floor, block-work walls, pitched roof clad with fibre-cement sheets, steel up & over garage door, timber single glazed windows and boarded timber door.

Internal dimensions approx. 8.5m x 6.0m.

There is also an aluminium framed greenhouse attached to the rear elevation of the Cottage.

Visually inspected.

Outside areas and boundaries

The site extends to approximately 4.38 acres, according to the Title Deed Plan, and is mostly laid to grass.

Tar and gravel parking areas.

Concrete paths around the house.

Visually inspected.

Ceilings

Plasterboard ceilings to the Cottage.

Sloping ceilings to the Extension are lined with timber

boarding.

Visually inspected from floor level.

Internal walls

Timber framed internal partitions, lined with plasterboard.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for

dampness where considered appropriate.



Floors

Suspended timber ground floor to the Cottage; concrete ground floor to the Extension.

Part of the opening in the first floor was filled in during 2015 to create additional useable floor space. These works were covered by a Building Warrant.

Internal joinery and kitchen fittings

Fitted floor and wall units to both Kitchens.

Softwood skirtings and facings.

Timber window cills and plywood ingoes.

Plywood doors to the Cottage; glazed softwood doors to the Extension.

Boarded wardrobe doors.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Chimney breasts and fireplaces

There are no chimney breasts or fireplaces.

Visually inspected. No testing of the flues or fittings was carried out.

Internal decorations

Internal walls and plasterboard ceilings are emulsioned. Woodwork is varnished or painted.

Tiled splashbacks to the Kitchen in the Cottage; upstands to the Extension Kitchen.

Shower panelling to the Cottage Shower Room; wall tiles to the Extension Shower Room.

Floor coverings include carpet, laminate and timber floor boards.

Visually inspected.

Cellars

There are no cellars.

Visually inspected where there was safe and purpose-built access.



Electricity

The property is served by a mains electricity supply to distribution boards and dual tariff meters.

Extractor hoods to both Kitchens.

Extractor fans to both Shower Rooms.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas

There is no gas installation.

Water, plumbing and bathroom fittings

The water supply is assumed to be from the mains. The pipework, where visible, is of copper and UPVC construction.

Sanitary ware includes:

Cottage Kitchen: 1.5 bowl stainless steel sink and drainer. Extension Kitchen: 1.5 bowl stainless steel sink and drainer.

Cottage Bathroom: bath with mixer shower above, wash-hand basin, WC.

Extension Shower Room: mixer shower with shower tray, wash-hand basin, WC.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation. No tests whatsoever were carried out to the system or appliances.

Heating and hot water

The property is heated by electric storage heaters and air to air units.

Oil fired stove in the Cottage Kitchen, which is understood to heat the domestic hot water.

Plastic oil tank in the garage.

The hot water cylinder is in a cupboard in the garage.

Electric focal point heater in the Extension Sitting Room.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.



Drainage

The property is understood to connect to a private septic tank on site.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Any additional limits to inspection:

At the time of our inspection the property was occupied and furnished, with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

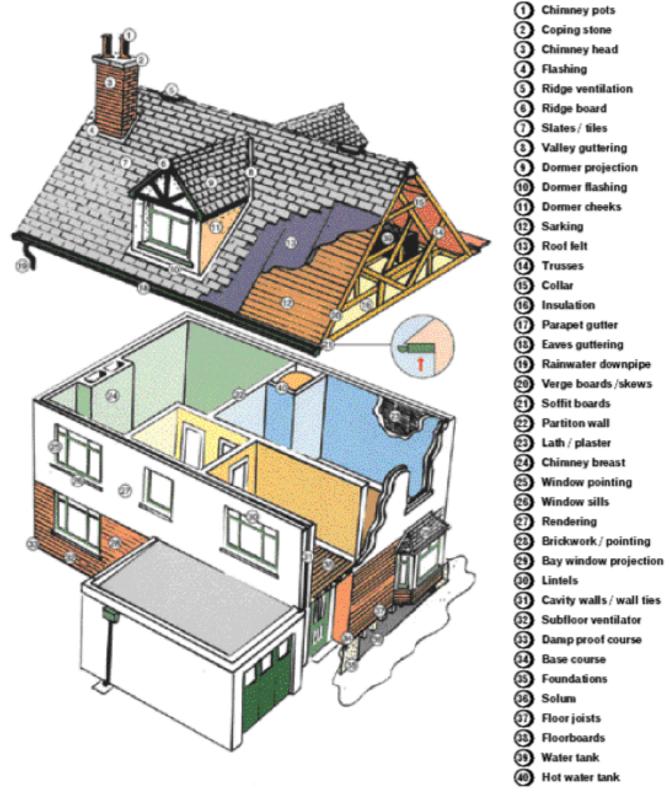
An inspection for Japanese Knotweed or other invasive plant species was not carried out. There was no access for inspection to behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney.

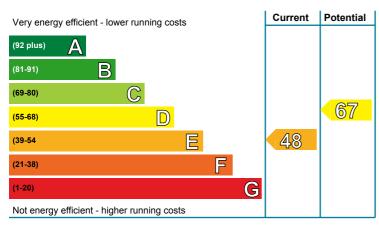

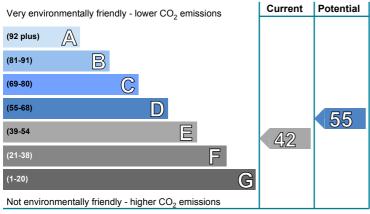

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 67 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 19 tonnes of carbon dioxide every year. About the recommended measures to improve your home's performance rating

1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

2 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

3 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting).

4 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

5 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

6 Wind turbine

PART 1 – GENERAL

1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report, the Surveyors reserve the right to reconsider the valuation. PART 2 – DESCRIPTION OF THE REPORT

2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.*

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased.
