\* VENDORS SUITED \* This 20th century detached cottage is located within a rural setting close to the village of Harmans Cross which sits in between the popular seaside town of Swanage and the historic village of Corfe Castle. The property has been extended over the years to offer substantial accommodation throughout which now includes the possibility to Airbnb.

As you enter the property you are greeted with the beautiful kitchen/diner. Double french doors lead out on to the substantial rear garden with views overlooking the Purbeck hills. The kitchen area benefits from a range of wall mounted and base units with work surface over. Integrated appliances include an oven with electric hob and extractor fan and dishwasher. There is space for a fridge/freezer. The lounge offers a warm feel with a beautiful feature Purbeck stone fireplace with log burner and beamed ceilings. There are three bath/shower rooms within the property. Off of the kitchen is a shower room/utility. It has space for a washing machine and tumble dryer as well as an enclosed shower cubicle, WC and wash hand basin. There are three double bedrooms. The master bedroom is located on the first floor and benefits from an en-suite bathroom. The bathroom benefits from a bath with hand held shower attachment, WC, wash hand basin. There is also a storage cupboard within the bathroom.

In 2022 the garage was converted to a third bedroom, entrance lobby and shower room. It is predominantly used as an Airbnb benefiting from it's own entrance with the owners making regular income from visitors to the area. The bedroom looks out on to the rear garden whilst the shower room has been finished to a high standard and benefits from a shower cubicle, WC and wash hand basin with built in vanity unit.

Externally, to the front is a gravel driveway providing off road parking. To the rear is a beautiful rear garden with views over the Purbeck countryside. Enclosed via a timber fence the garden also benefits from a laid lawn, flower and shrub borders and a stone paved patio. There is access down the side which leads to a covered storage area.

Services include mains water & electricity, oil central heating and septic tank drainage.

The rural village of Harmans Cross is located in between the seaside resort of Swanage and the historic village of Corfe Castle. The popular railway serves Corfe Castle to Swanage. The popular beaches stretch for miles along the Jurassic coast. The town of Wareham is approximately 8 miles away and Wareham train station is ideal for commuters looking to travel to London.






#### **Road Map**

#### **Hybrid Map**


#### **Terrain Map**








#### Floor Plan
