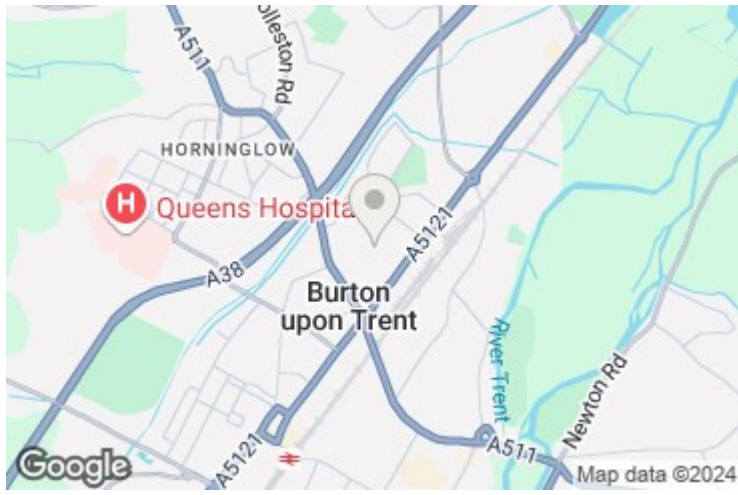

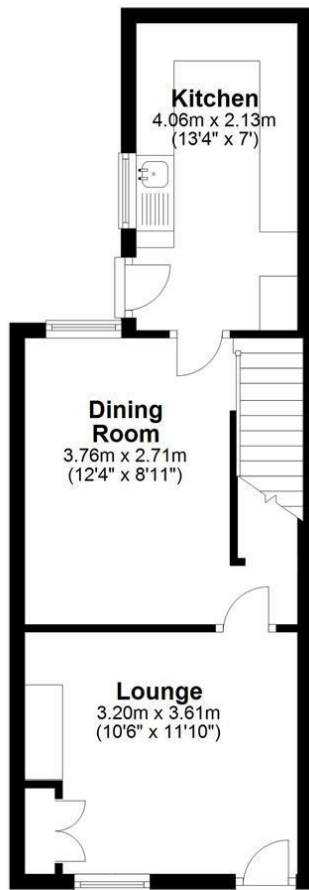

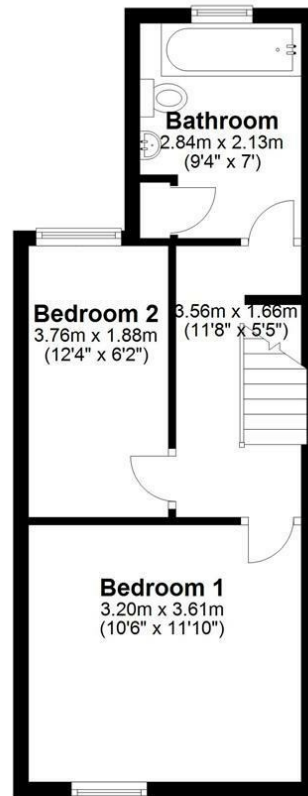




Ground Floor
