The home opens with a front UPVC door leading to the lounge with meter cupboard and radiator and door into the dining room with a useful below stair storage cupboard, radiator and window to the rear aspect.

The kitchen along the rear aspect has a selection of units and freestanding appliance spaces with door and windows facing the rear garden.

The first floor has two double bedrooms, the larger across the front elevation, the second bedroom having a built-in cupboard housing the gas fired combination boiler. The bathroom offers a WC, hand wash basin and bath with thermostatic shower above, radiator and window to the rear aspect.

Outside there is a shared entry to the rear garden.



First Floor



