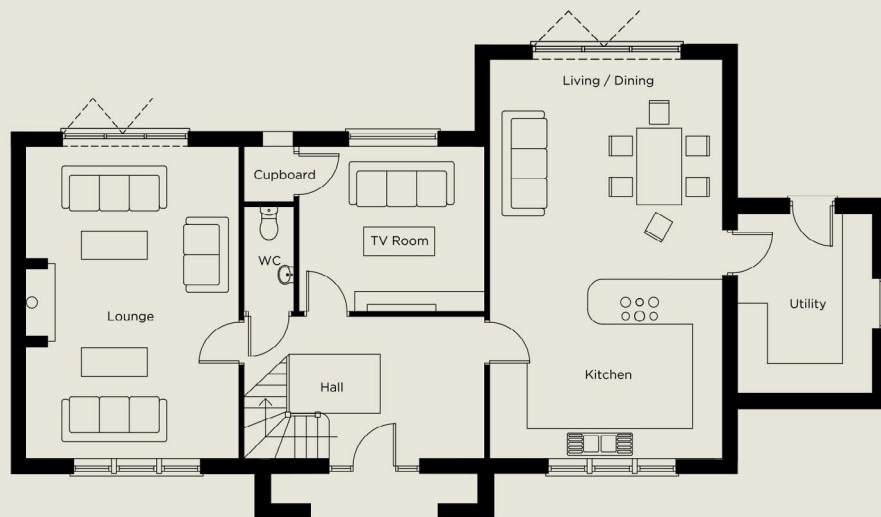

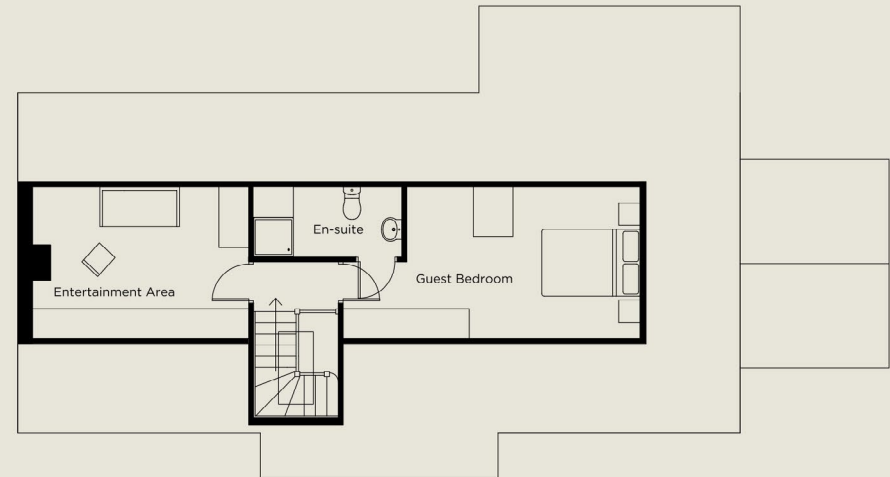


THE HEATON FLOOR PLANS

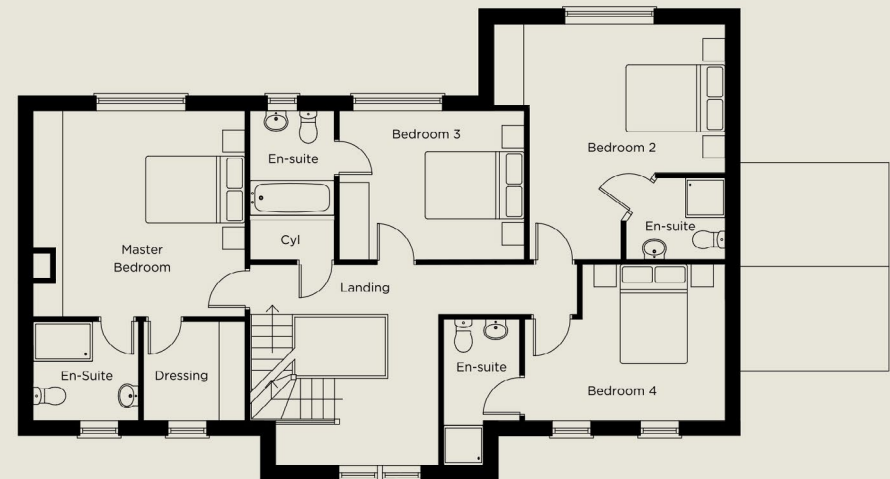
GROUND FLOOR



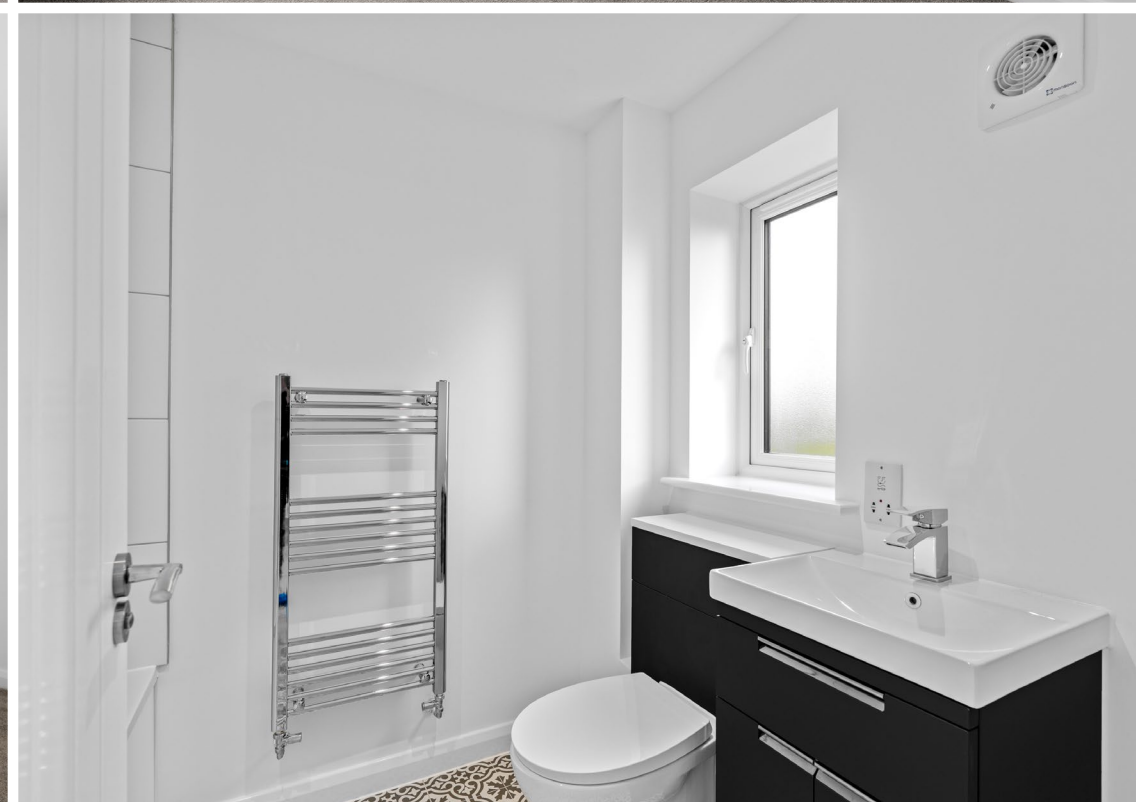
SECOND FLOOR
