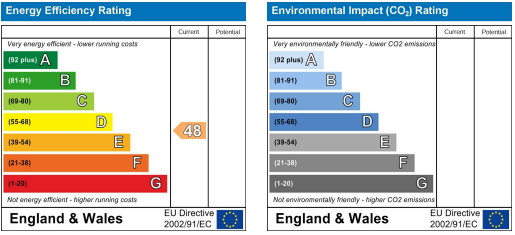
Floor Plan
