




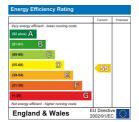


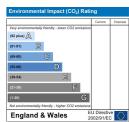
### Floor Plan Area Map
