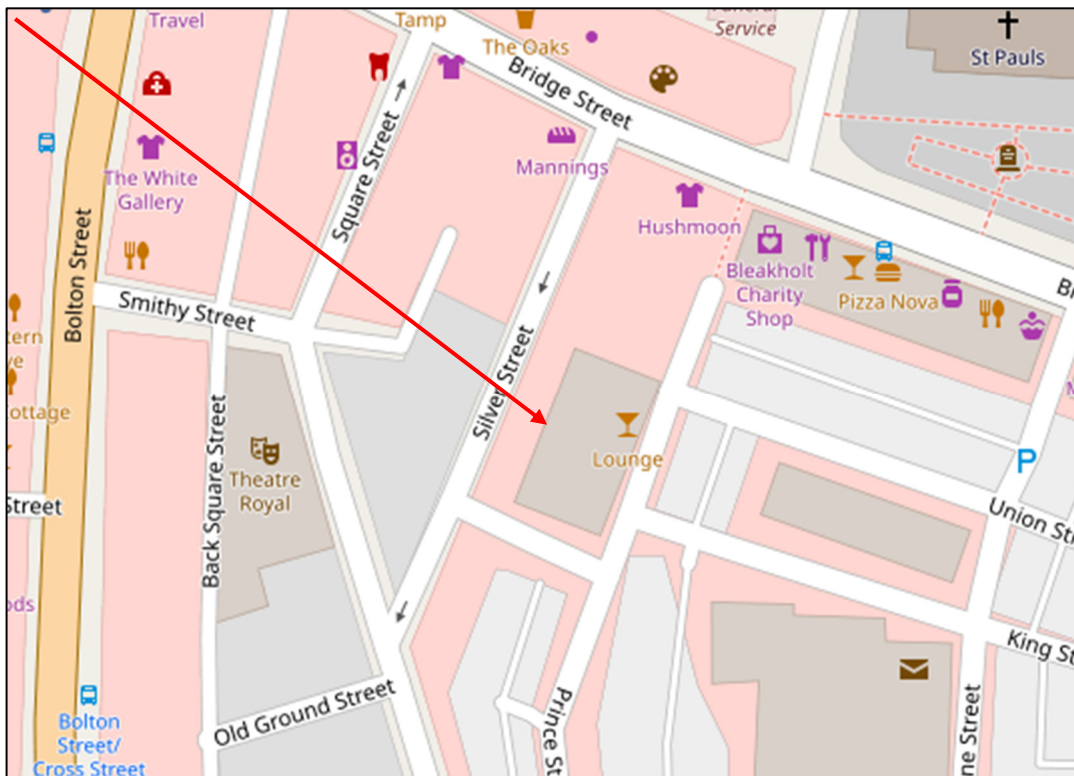
Description
