

# FOX COVERT YARD

Goring Road, nr Woodcote, South Oxfordshire RG8 7SL



Fox Covert Farm is a commercial premises situated off the B471 Goring Road near Woodcote. A rare opportunity has now arisen to rent a secure Contractors Yard which has been operating as a base for a demolition company for a number of years and will be available with vacant possession from January 2024. The premises include a large external storage yard and a small Nissen barn. A portacabin office space is available by separate negotiation with the outgoing tenant.

#### Location

The premises are situated 0.5 miles south of Woodcote on the B471 Goring Road, with good access to Wallingford in 15 minutes (7.5 miles) and Reading and the M4 motorway in 20 minutes (9 miles).

#### **Features**

- External yard area (hardstanding) of approximately 1244m<sup>2</sup> (13,400 square feet)
- Nissen type barn of approximately 55m<sup>2</sup> (600 square feet)
- Mobile office/welfare unit of approximately37m<sup>2</sup> (400 square feet) available by separate negotiation
