




# **113 OCEAN CLUB ESTATES** Ocean Club Estates, Paradise Island US\$13,780,000

This one-of-a-kind waterfront Venetian style palace offers breathtaking ocean and Nassau harbour views. Located in the luxurious Ocean Club Estates community on Paradise Island, the villa's interior was designed by world renowned designer Steven Zelman, with an island/Euro contemporary flare. As you approach the property you are met with a hand-laid brick driveway that takes you to a majestic porte-cochère with 40 ft (12 m) pillars giving the home a grandiose feel. As you walk through the 15 ft (4.6 m) double mahogany door your breath is taken away by the 35 ft (10.7 m) cathedral ceilings and 30 ft (9 m) Palladian style windows that offer magnificent water views of your very own private marina and Nassau Harbour. No expense was spared in redesigning the home, from a 1 of 1 Mother of Peal mantel, custom made New Zealand wool and India silk rugs, and custom 7 ft (2 m) chandeliers painted by Ferrari and adorned with crystals. The open plan floor design allows for guest to flow freely throughout the home and enjoy all the different entertaining areas the house has to offer. The main house consists of four bedrooms, additionally there are two very spacious private guest cottages each with its own kitchenette and walk-in closet and private porches that open to the lush, landscaped gardens. One of the most talked about features of the estate is its expansive back garden. Highlighted by an oversized swimming pool, a jacuzzi spa under a stone gazebo and your very own private marina dock that can accommodate boats up to 120 ft (36.6 m). Ocean Club Estates features an 18-hole championship golf course designed by Tom Weiskopf, tennis courts and a private beach club on the world-famous Paradise Beach. Ocean Club Estates residents also enjoy use of all the facilities at the Atlantis Resort & Casino and the Ocean Club Four Seasons Resort. Paradise Island is connected to New Providence (home of Nassau, capital city) by two bridges.

There are direct flights to the Lynden Pindling International Airport (LPIA) in Nassau from London, New York, Toronto, Atlanta, Charlotte, Miami, Fort Lauderdale, Orlando, Boston, Chicago, Dallas-Fort Worth, Los Angeles, Philadelphia, Tampa, West Palm Beach and other cities.

There is a private airfield next to the Lynden Pindling International Airport.

Once you arrive at the airport or private airfield, you can take a taxi or rent a car and travel to Paradise Island. Travel time approx. 35 minutes.

Situated 50 miles (80 km) off the southeast coast of Florida and continuing in a southeastwardly direction for about 750 miles (1,207 km), The Bahamas is also just north of the Caribbean islands of Cuba and Hispaniola (Haiti and the Dominican Republic). Nassau, the capital city is located on the island of New Providence in the Central Bahamas. The country is a coral archipelago, and limestone is the primary rock composition of the islands. With 5% of the Earth's coral, no rivers or mountains, the waters surrounding The Bahamas are virtually silt free resulting in some of the clearest waters on the planet.
