



LINK STREET/PONSFORD STREET, HACKNEY, LONDON, E9 6JU RARE OPEN STORAGE PLOT – TO LET

The site is located between Ponsford Street and Link Street within the London Borough of Hackney. The site sits adjacent to and below the London overground line linking Highbury and Islington with Stratford. Vehicular access to the site is via the southbound carriageway of Ponsford Street accessed via Homerton High Street (A102) approximately 100m to the north.
