Location

The unit is situated on a prime trade counter pitch within St James Trade Park. The unit is located immediately off St James' Mill Road which adjoins the A4500 providing direct access to Northampton Railway Station and the Town Centre. This represents a rare opportunity to join this prestigious line up of trade occupiers.

Description

St James Trade Park is a prime trade counter scheme located within the heart of Northampton. The estate comprises a terrace of trade counter units of steel frame construction which were completed in 2009. The property comprises brick external walls, with profiled steel cladding. The former Nisbets unit comprises 5,915 sq ft of trade counter accommodation, benefitting from allocated parking and prime road frontage.
