A rare opportunity to occupy a low density industrial/ distribution property in a popular East London Location. Adtatched building currently used as a Trade Counter and showroom benefitting from a single full height loading door.

Externally there is a mix of concrete and tarmac storage, all fully secured with palisade fencing and perimeter flood lighting. Additionally, a number of full and lower height arches provide dry secure storage.
