



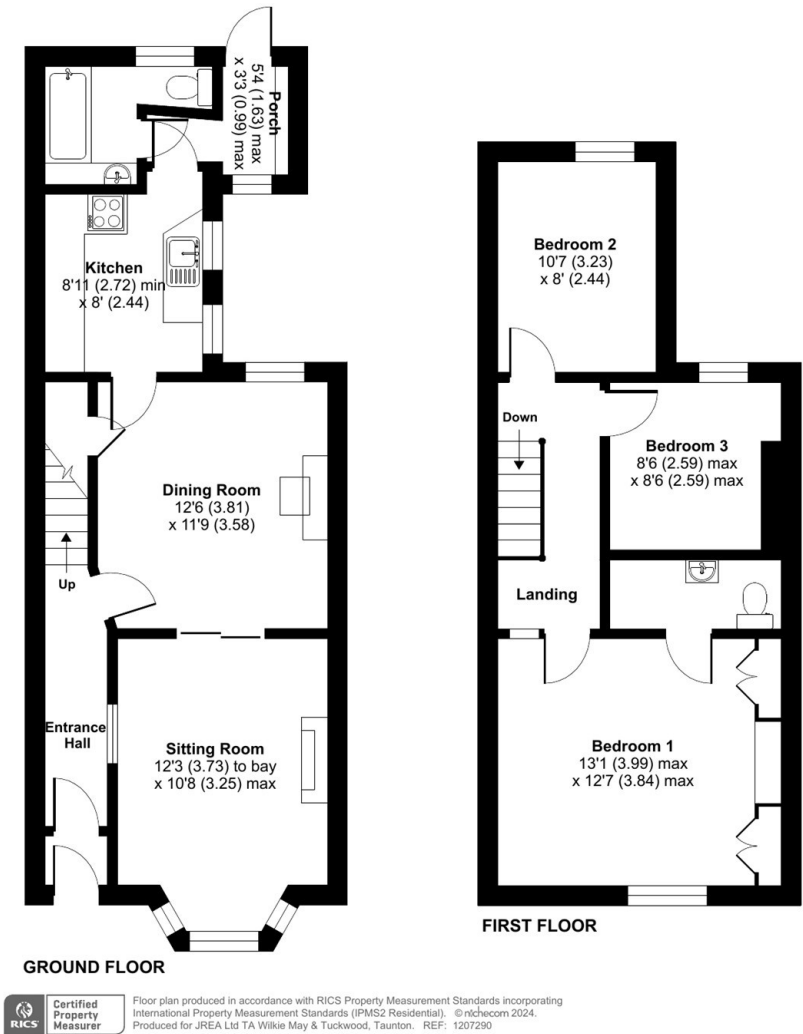

# Description

Offered to the market with vacant possession and no onward chain is this three bedroom Victorian mid terrace home.

The property is situated in the Rowbarton area of Taunton, close to the railway station, schools and local amenities.

There is a mains gas fired central heating system and some uPVC double glazing. The property is in need of modernisation throughout and presents an exciting opportunity for investors, or DIY enthusiasts.

The accommodation is arranged over two floors and comprises in brief; entrance hallway with stairs rising to the first floor, living room with bay window providing aspect to the front, dining room with a gas fire and window providing aspect to the rear, kitchen with a selection of matching wall and base storage units with work surfaces above, space and plumbing for a washing machine and space for a cooker. There is a ground floor bathroom comprising low level wc, wash hand basin and panelled bath. The ground floor accommodation is completed with a rear porch which has a uPVC double glazed door providing access into the rear garden.

On the first floor there are three bedrooms (bedroom one with an en-suite WC and wash hand basin). Externally, there is a fully enclosed courtyard garden predominantly laid to paving with a timber shed and greenhouse. To the front of the property there is a smaller area of garden, ideal for storage of bins/recycling boxes etc.
