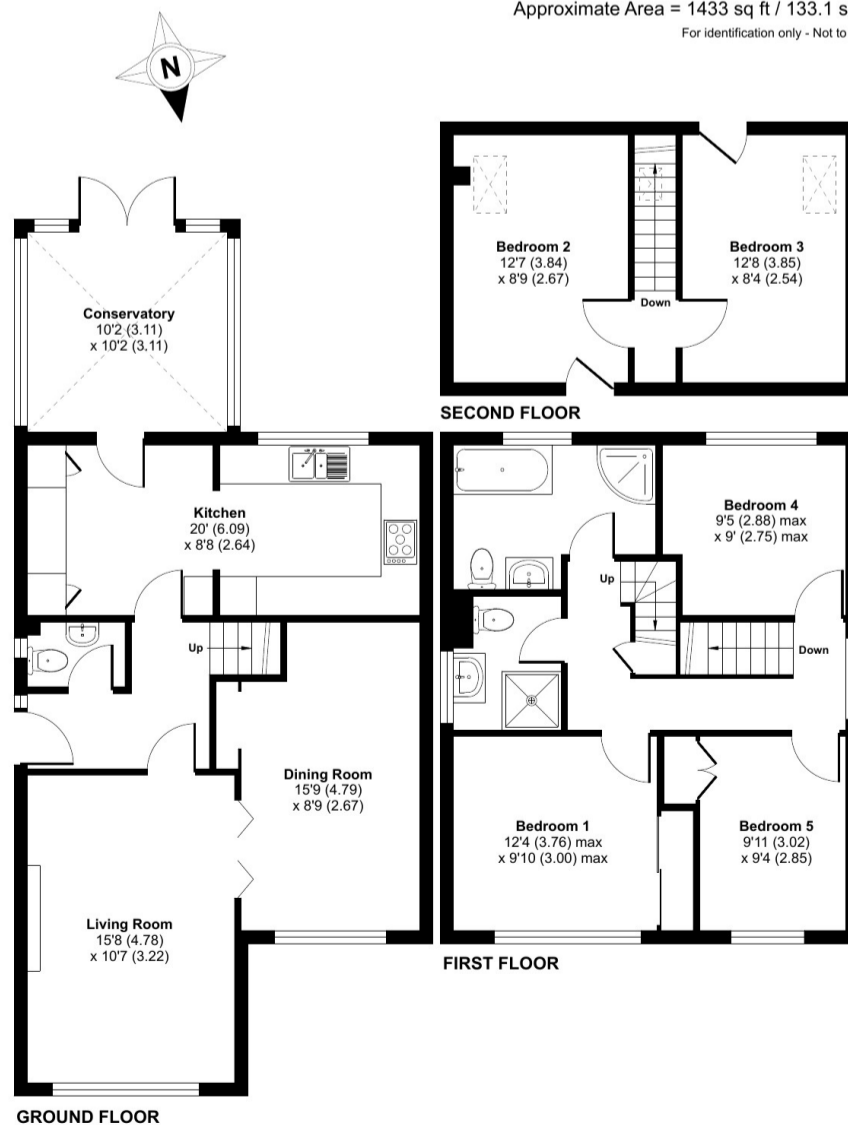

# Description

A five bedroom modern detached family home occupying a cul-de-sac position within the popular Blackbrook development.

The property, which benefits from uPVC double glazing and gas fired central heating, is further enhanced by a double glazed conservatory and enclosed garden.

Over recent years, the property has been altered with the conversion of the garage into a dining room and the creation of two additional bedrooms in the loft space. As a result, the first floor layout has been altered and now benefits from both a bathroom and separate wc.

Internally, a front door leads into the entrance hall with staircase rising to the first floor and doors to the living room and kitchen. To the front of the property, there is a generous size living room with access into a separate dining room. A large kitchen offers a range of matching wall and base units, roll edge work surfaces and tiled splashbacks with integrated oven, gas hob and extractor fan with space for a washing machine and an American fridge/freezer. There is also space for a tumble drier as well as sliding patio doors that leads through to a double glazed conservatory. A cloakroom completes the ground floor accommodation.

To the first floor are three bedrooms, two of which have fitted wardrobes. There is a generous size family bathroom comprising of wc, wash hand basin, bath and separate walk-in shower, as well as a useful separate shower room with wc, wash hand basin and walk-in shower. There are two further bedrooms on the second floor. Externally, the rear garden is fully enclosed and offers gated side access. A patio adjoins the rear of the property and the garden is subdivided with a picket fence with access through to an area of lawn and an ornamental pond.
