

Internally, a front door leads into entrance hall. The ground floor accommodation comprises; a generous size living room with bay window to the front, a separate dining room. A generous size kitchen/breakfast room is fitted with a range of wall and base units, roll edge work surfaces and tiled splashbacks with integrated stainless steel double oven, hob and extractor fan.

From the kitchen, access can be gained through to a useful utility room and ground floor cloakroom. From the hallway, a staircase rises to a first floor landing where you will find four bedrooms, a family bathroom and separate shower room. Externally, there is a fully enclosed courtyard garden.
