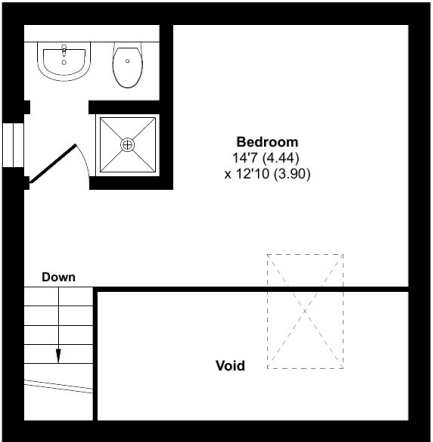
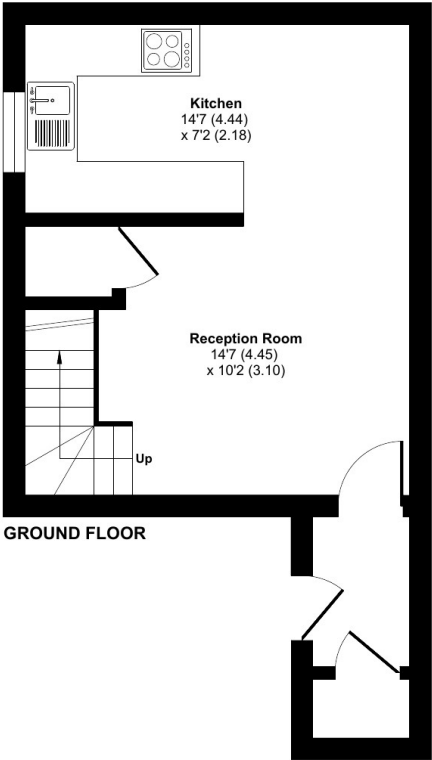

Internally, a front door leads into entrance porch with further door into the main living area. The ground floor has an open plan feel and merges into a kitchen/dining area. The kitchen is fitted with a range of wall and base units, work surfaces and tiled splashbacks with space for cooker, space and plumbing for washing machine and a double glazed window to the side.

From the living area, a staircase rises to a mezzanine first floor bedroom with Velux window and a shower room completes the accommodation.
