





Description

Set in the wing of the Grade II Listed 192 Kingston Road, is this one bedroom, two storey leasehold maisonette which is offered to the market in good decorative order.

The property, which benefits from spacious accommodation, is served via gas fired central heating and must be viewed internally in order to fully appreciate.

In brief, a private front door leads through to entrance hall with access through to a living room, a staircase to the first floor and a ground floor bathroom. The living room is of generous proportions with a large front aspect window. There are steps down to a modern kitchen, which is fitted with a range of matching wall and base units, roll edge work surfaces and tiled splashbacks with space for cooker, space and plumbing for washing machine and space for tall fridge/ freezer.

A family bathroom suite comprising of wc, wash hand basin and bath with tiled surround and shower over completes the ground floor. From the hallway, a staircase leads up to a generous size double bedroom with fitted wardrobe and storage area. The property is set in well kept communal gardens and offers communal parking.


