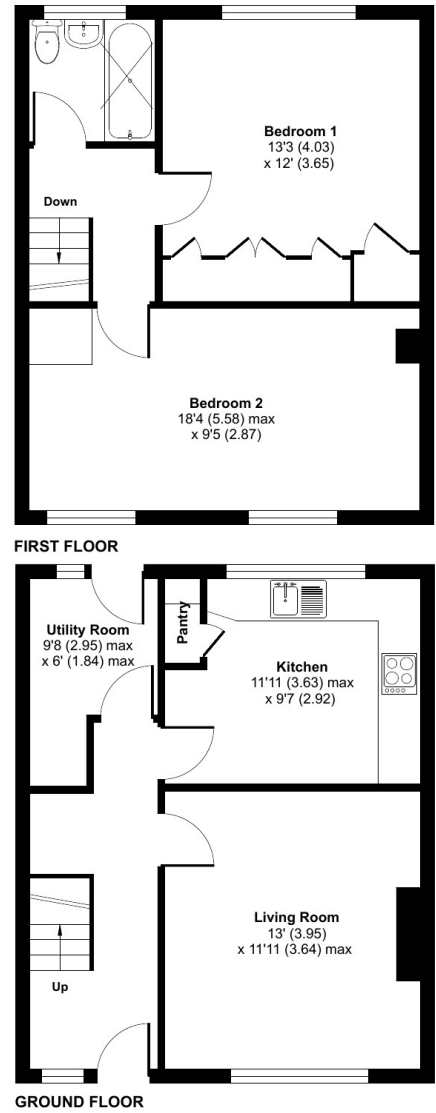

Description

Situated in a cul-de-sac position, close to the centre of Wiveliscombe, is this two bedroom ex-authority home.

The property, which offers good size accommodation arranged over two floors, is benefitted by uPVC double glazing and mains gas fired central heating.

The property is further enhanced by a fully enclosed rear garden and is offered to the market with no onward chain.

Internally, a front door leads into entrance hall with doors to all principle ground floor rooms, as well as a staircase rising to the first floor. The living is found to the front of the property with a fitted kitchen behind. The kitchen is fitted with a range of base units, work surfaces and tiled splashbacks with space for a cooker, space and plumbing for a washing machine and space for a tall fridge/freezer as well as a wall mounted gas boiler.

There is a useful utility room with a doorway giving access to the rear. From the hallway, a staircase leads to a first floor landing with doors to two good size double bedrooms along with a family bathroom. The bathroom comprises of wc, wash hand basin, bath with tiled surround and shower over. Externally, there is a private rear garden which is laid predominantly to lawn and is not overlooked.
