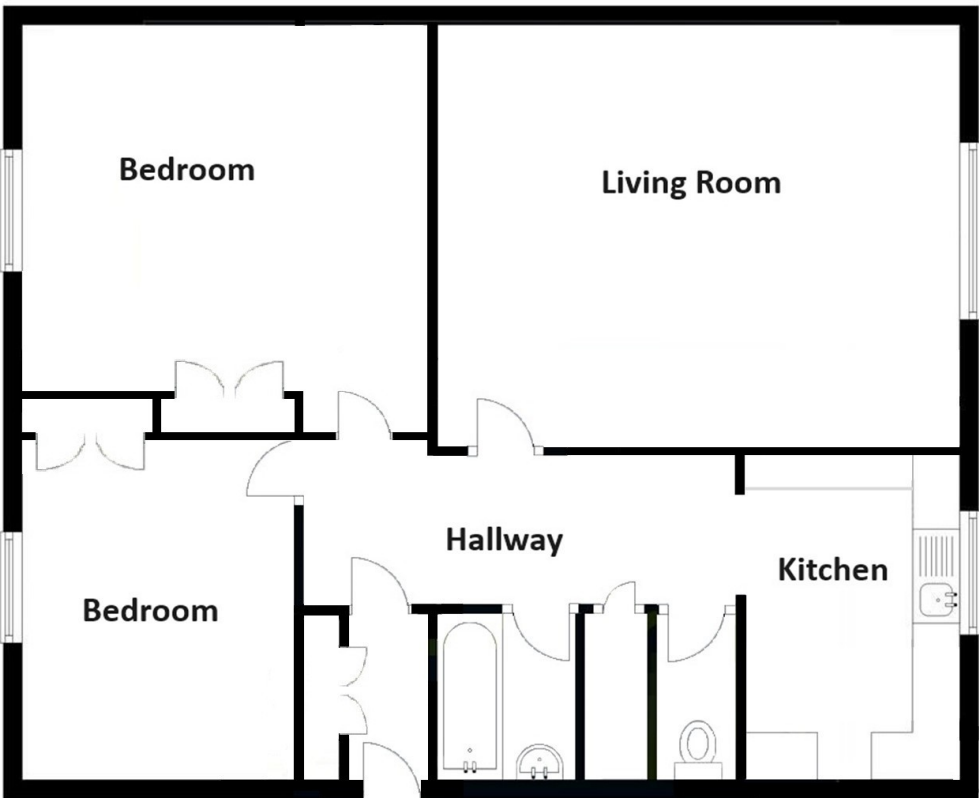

In brief, the spacious accommodation comprises; front door leading into entrance hall with doors to all principle rooms. There is a generous size living room with dual aspect windows to side and rear and an electric heater.
