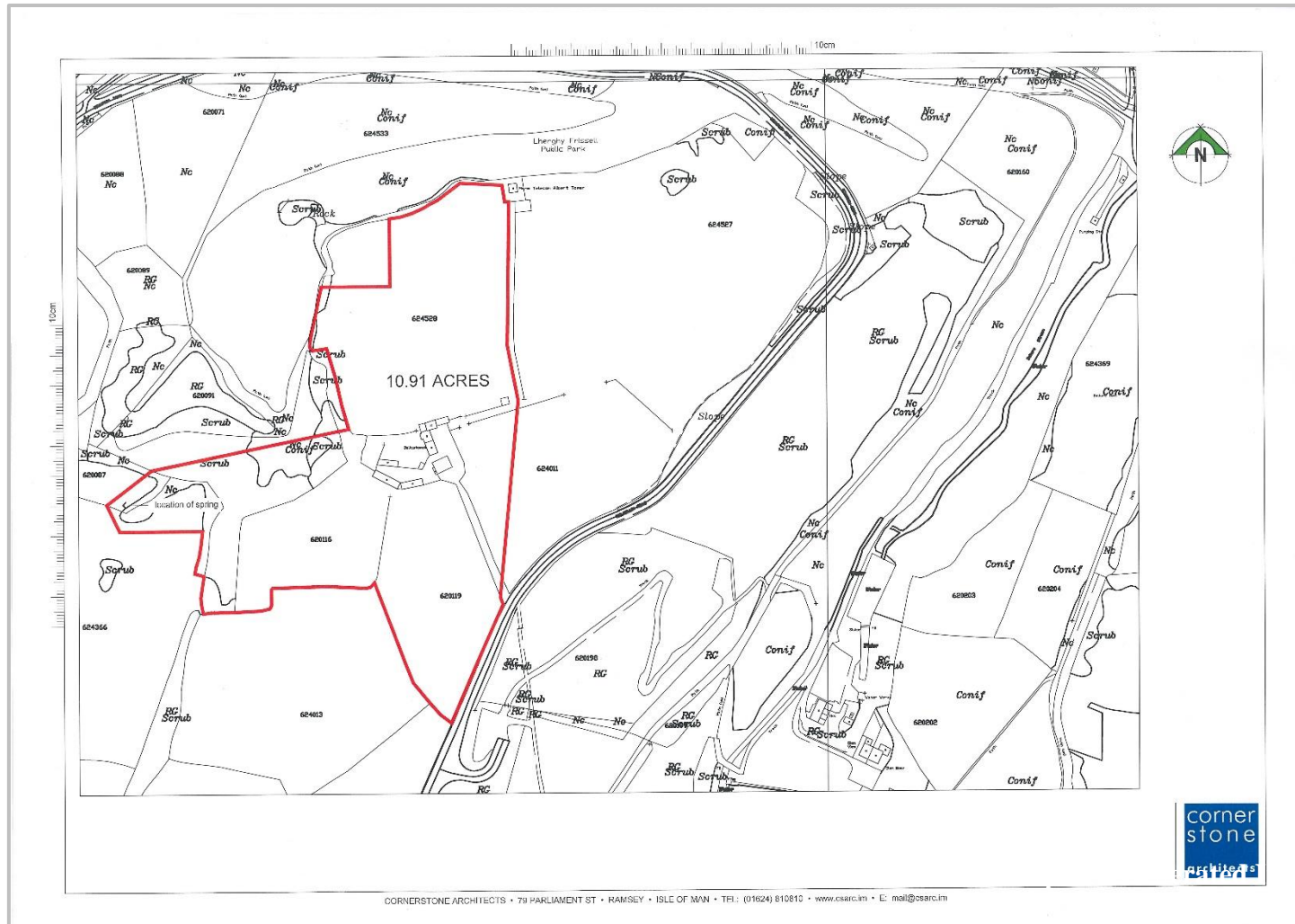

LOCATION

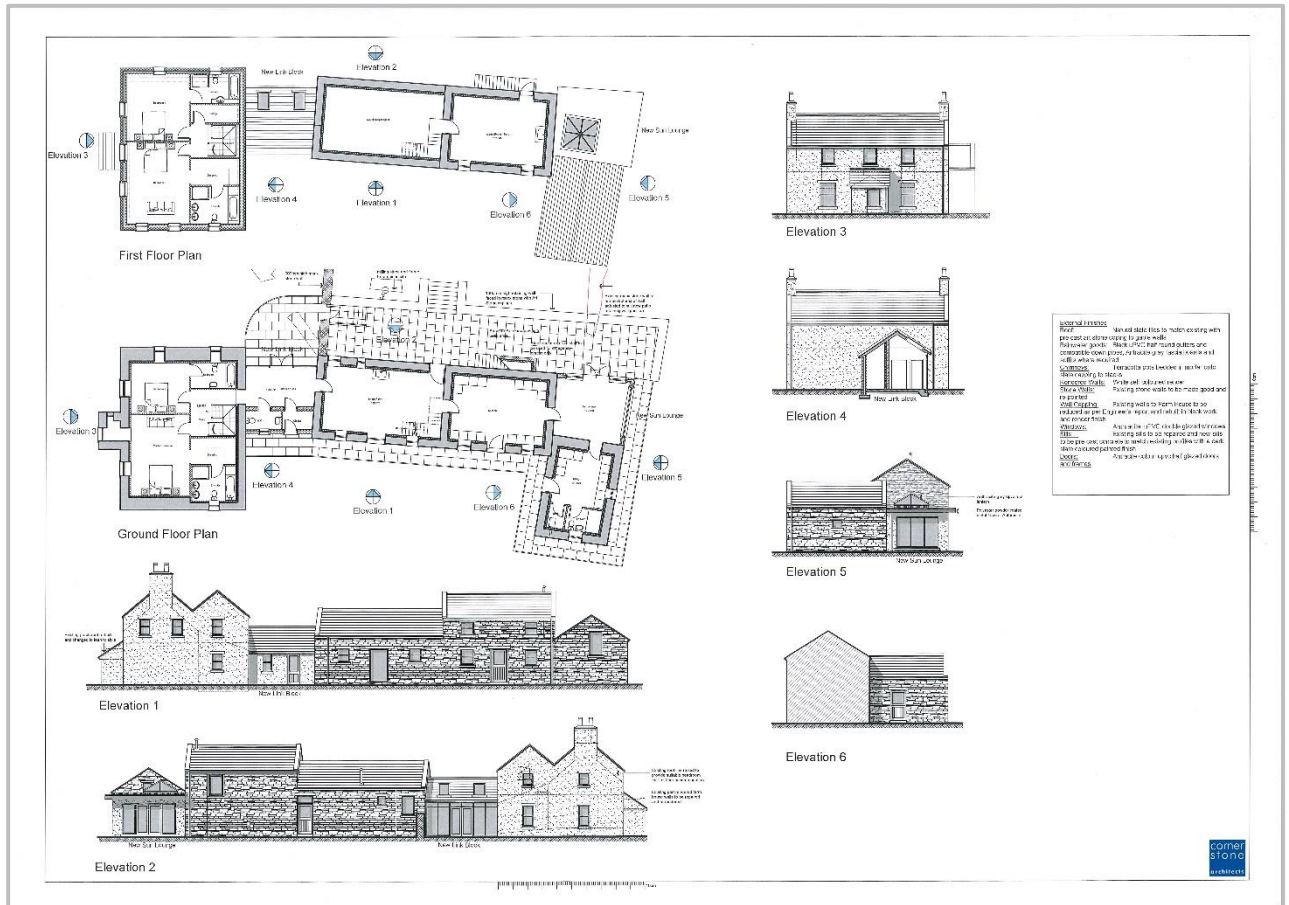
