The property comprises of three one bedroom apartments, a spacious two bedroom apartment and two studio apartments. Five units are currently let and generating income, while one is vacant and awaiting refurbishment.

Currently managed by the owner, the block brings in £32,040 annually, with considerable potential to enhance returns through refurbishment and rent increases. Full of untapped potential, this building offers an incoming purchaser the opportunity to add significant value.

Additionally, the neighbouring apartment block, Silverburn, is available from the same vendor, opening the door for those seeking to expand their portfolio with a larger investment.

Location

From Parliament Square head south on Queens Pier Road, turn left into Albert Street and continue into Waterloo Road. Take the right into Queens Drive, then the next right onto Queens Pier Road, followed by an immediate right into Brookhill Road. Ben Eaden is located on the left.

Accommodation

Flat 1, features a lounge, kitchen, two bedrooms, bathroom, access to rear yard and is serviced by oil. Refurbishment works required.

Flat 2, comprises a lounge/bedroom, kitchen and a shower with WC.
