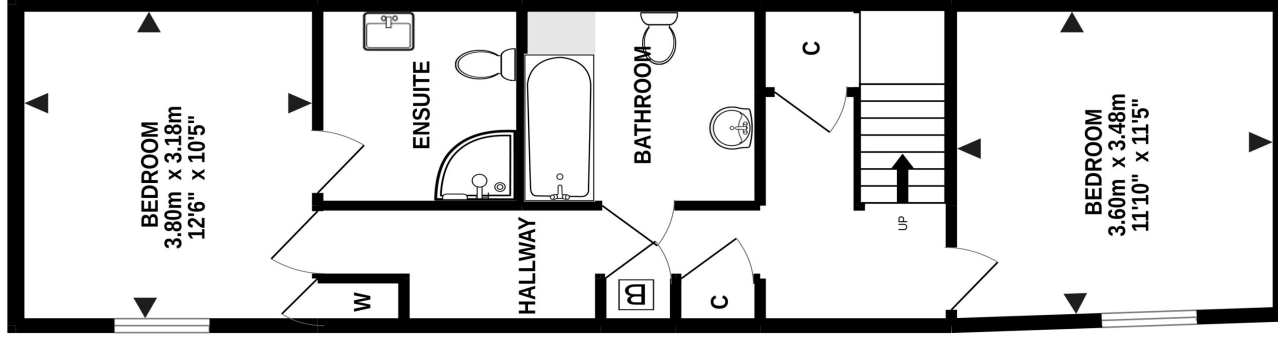

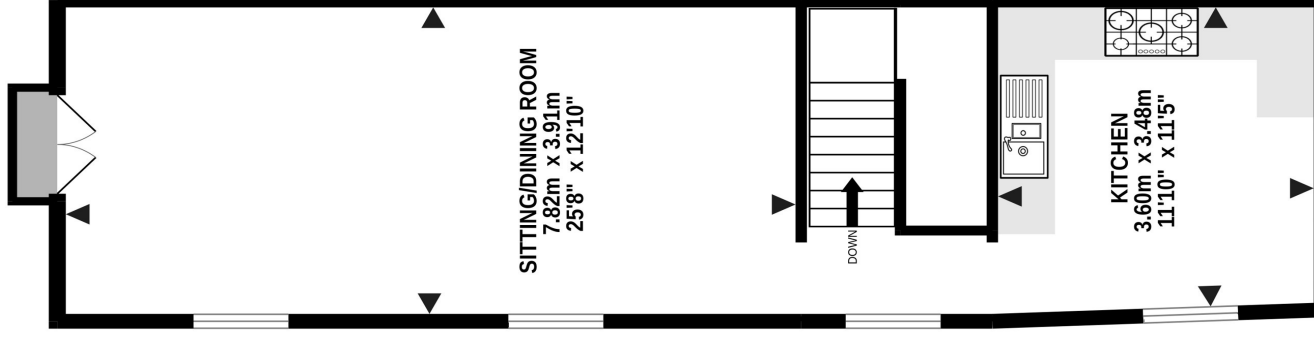

Description

A stunning and spacious semi detached barn conversion, situated in the heart of the town centre, with parking and No Onward Chain.

THE ACCOMMODATION COMPRISES IN BRIEF: Situated in the heart of Watchet's Conservation area, is this substantial two bedroom modern barn conversion offered for sale with No Onward Chain. The property will be found in excellent condition throughout, and is just a few moments walk from amenities, the West Somerset Steam Railway Line and Marina. Equipped with double glazing, and gas central heating, together with an easily maintained garden and off road parking for 3 vehicles, this spacious property must be viewed to appreciate.

The accommodation in brief comprises; Solid wooden door with inset viewing pane, into spacious Entrance Hall; travertine tiled flooring with underfloor heating system, two built-in storage cupboards with one housing the Worcester combi boiler for central heating and hot water, window recess with telephone point under, under stairs Utility Cupboard; with space and plumbing for washing machine, door into Ground Floor Bathroom; with travertine tiled flooring, white suite comprising panelled bath with mixer shower attachment over, tiled surround, low-level WC, pedestal wash basin with tiled splashback, light and shaver point over, heated towel rail. En-suite Master Bedroom; aspect to front overlooking courtyard garden, built in single wardrobe, door into En-suite Shower Room; with travertine tiled floor, corner shower cubicle with thermostatic mixer shower over, tiled surround, low-level WC, pedestal wash basin, light and shaver point over, heated towel rail. Bedroom 2; aspect to front exposed ceiling beams.

Stairs to 1st floor, open plan Living Room/ Dining Room with oak flooring, double aspect, TV point, telephone point, Juliet balcony, exposed ceiling beams, exposed woodwork to Kitchen/Breakfast

area, with oak wood flooring, oak fitted kitchen with granite effect rolled edge worktops, 1 and a 1/2 bowl stainless steel sink and drainer, mixer tap over, tiled splashbacks, space for range oven, extractor fan over, integrated dishwasher, space for tall fridge freezer, space for breakfast table.



OUTSIDE: The property has off-road parking for 2/3 vehicles. The garden is situated adjacent behind a local stone wall and is laid to gravel for ease of maintenance with a central planted bed.
