#### ACCOMMODATION



The accommodation in brief comprises, Composite door into spacious Entrance Hall, tiled floor, door into Ground Floor Wet Room with tiled floor and walls, thermostatic mixer shower, low level WC, wash basin. Study/Bedroom 5 with aspect to front. Living Room/Dining Room; with triple aspect, bifold doors to the rear garden, bay window to the front. Kitchen/Breakfast Room; aspect to rear, tiled floor, bespoke fitted kitchen comprising an excellent range of coloured cupboard and drawers under a quartz worktop with inset one and a half bowl stainless steel sink and drainer, mixer tap over, integrated dishwasher, integrated fridge/freezer, range oven with extractor hod over, breakfast bar. to side garden, plant room, worktop to match kitchen with space for washing machine under. Stairs to first floor landing; **Principal Bedroom 1**; with a double aspect, dressing room, built in wardrobe, shower room with a corner shower cubicle with thermostatic mixer shower over, low level WC, wash basin inset into vanity unit. **En-Suite Bedroom 2**; aspect to rear, built in wardrobe, door into **Shower Room**; with shower cubicle with thermostatic mixer shower over, low level WC, wash basin. **Bedroom 3**; aspect to front, built in wardrobe. **Bedroom 4**; aspect to front, built in wardrobe. **Family Bathroom**; with white suite comprising a four-piece suite, panelled bath, low level WC, wash basin.













### OUTSIDE

There is a detached double garage with electric up and over door, and a personal door to the garden. The remainder of the garden wraps around the house and is laid to lawn with a decking platform and storage shed.








#### FLOORPLAN
