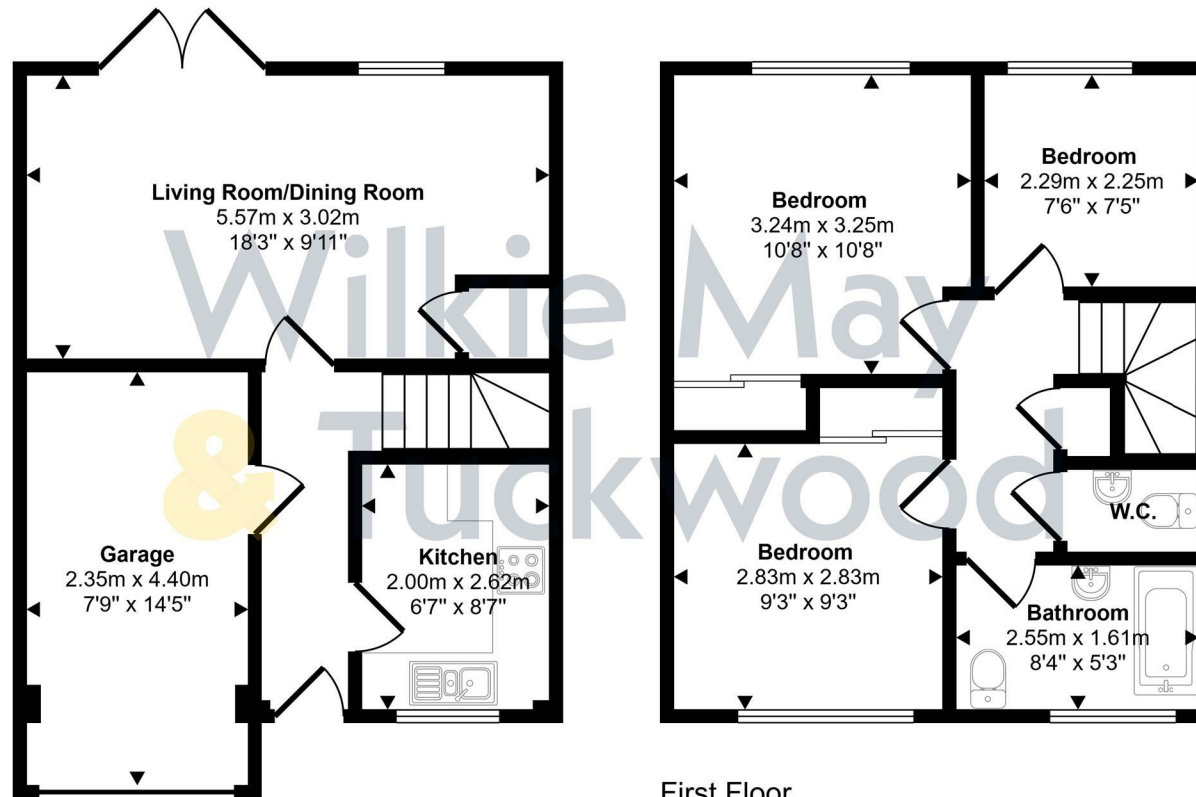

The property comprises a semi-detached house of traditional brick construction under a tiled roof with the benefit of full uPVC double glazing and gas central heating. The accommodation will be found in good order throughout but would benefit from some cosmetic modernisation.

The accommodation in brief comprises; Door into Entrance Hall.

Archway into Kitchen; with aspect to the front, wood effect cupboards and drawers under a granite effect rolled edge worktop with inset one and a half bowl stainless steel sink and drainer, mixer tap over, tiled splashbacks, wall mounted Ideal gas fired boiler, fitted electric oven with four ring gas hob and extractor fan over, space and plumbing for a washing machine, space for a tall fridge/freezer.

Door into Garage.

Door into Living Room/Dining Room; with an aspect to the rear, French doors to the rear garden, ample room for a dining table, under stairs storage cupboard.

Stairs to first floor Landing; with hatch to loft space, airing cupboard.

Bedroom 1; aspect to rear, with built in wardrobe. Bedroom 2; aspect to front with built in wardrobe. Bedroom 3; aspect to rear.

Family Bathroom; with white suite comprising panelled bath with tiled

surround, mixer shower attachment, low level WC, pedestal wash basin. Separate WC; with low level WC, wash basin.

OUTSIDE: The property benefits from off road parking and a Garage with up and over door, power and lighting. There is a personal door from the Garage leading into the Entrance Hall. To the rear of the house there is an enclosed garden.
