The accommodation comprises of an entrance hall, lounge to the front of the home and kitchen diner to the rear, with the kitchen diner hosting access to the useful downstairs WC and access to the rear garden, whilst upstairs the first floor landing separates three bedrooms, two of which boast built-in storage, as well as the family bathroom, which benefits from a three-piece white suite with shower over the bath. Outside there are low maintenance gardens to both front and rear, with the rear garden also hosting a garden room with a hot tub, in addition to rear gated access leading to a communal parking area.
