This excellent Storrington site adjoins National Trust land and is set on high ground with views to the South Downs and South Downs National Park; Planning permission has been granted for the development of six detached houses, with only 3 remaining.

These plans may be tailored by the owners and resubmitted before construction, representing a rare opportunity in today's market. This means that you can work with a developer and with their architects to redesign the size, shape and look of your new home, specifying exactly what you want. Just purchase the plot and build out the already approved design.

The site has been reformed and landscaped to produce 6 excellent residential plots varying in size, all with excellent communications, minutes from the shops and schools, and with wonderful views south towards the

Downs and east to Chanctonbury Ring.

All the infrastructure will be in place; these are rarely available fully serviced plots.

This is a rare chance to build your own home without the hassle and risks involved in locating a site and obtaining all the necessary planning approvals that can take years. This is a truly unusual opportunity.

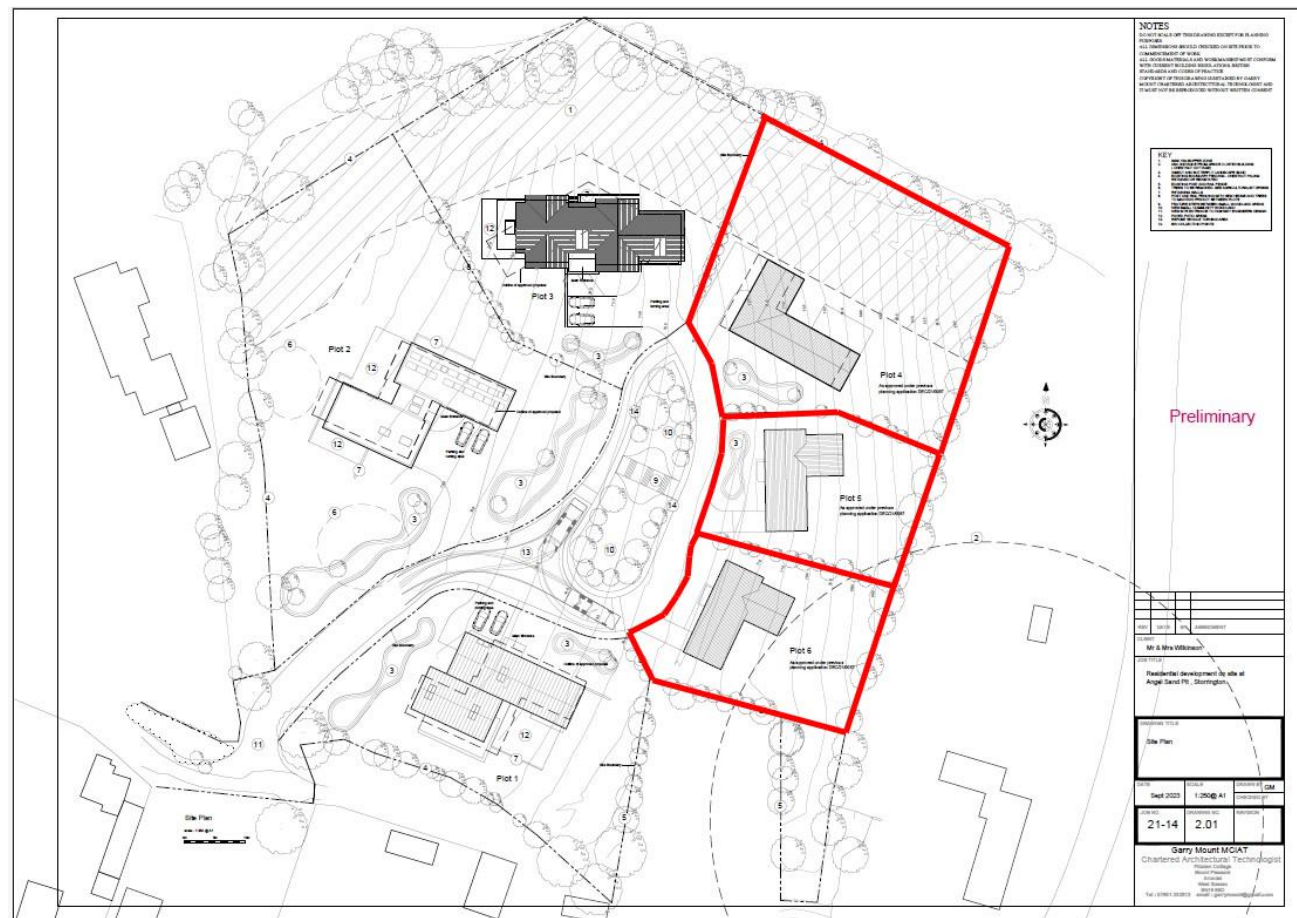
