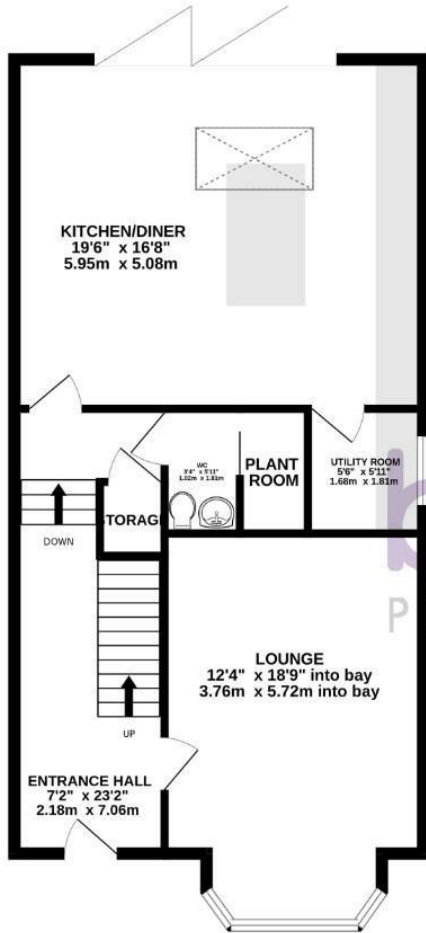

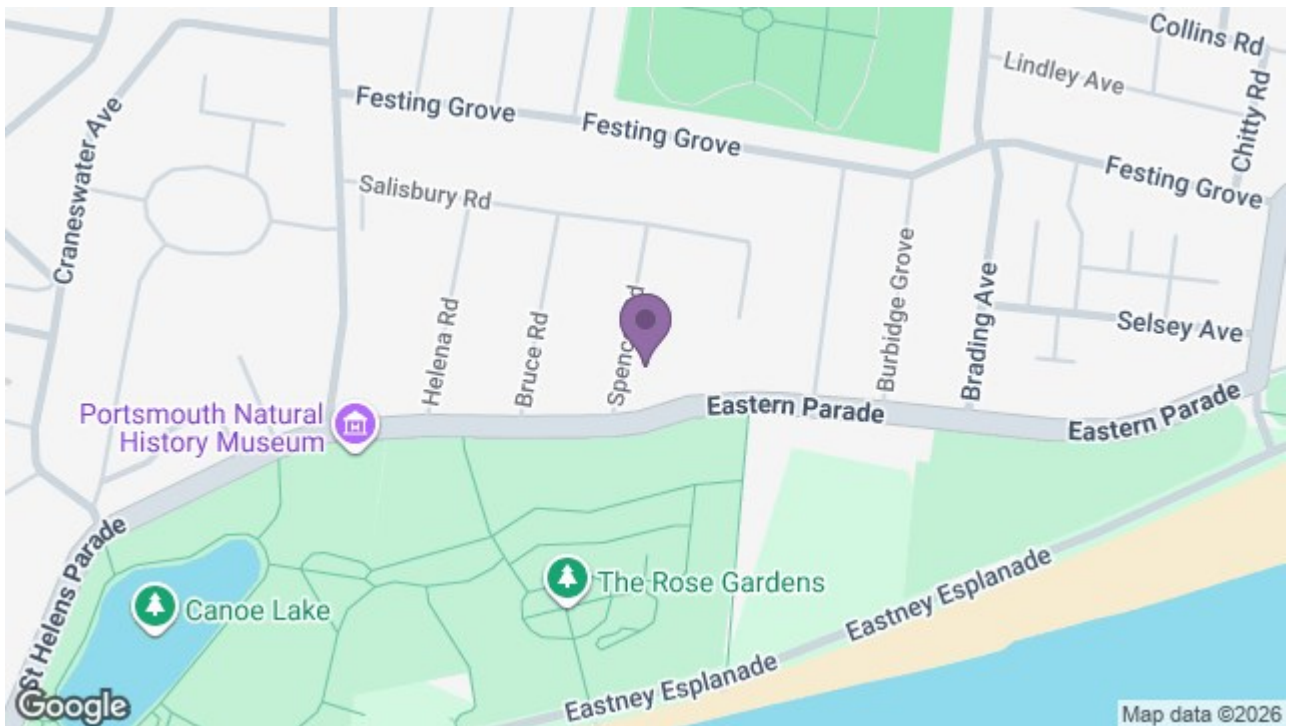


2ND FLOOR
