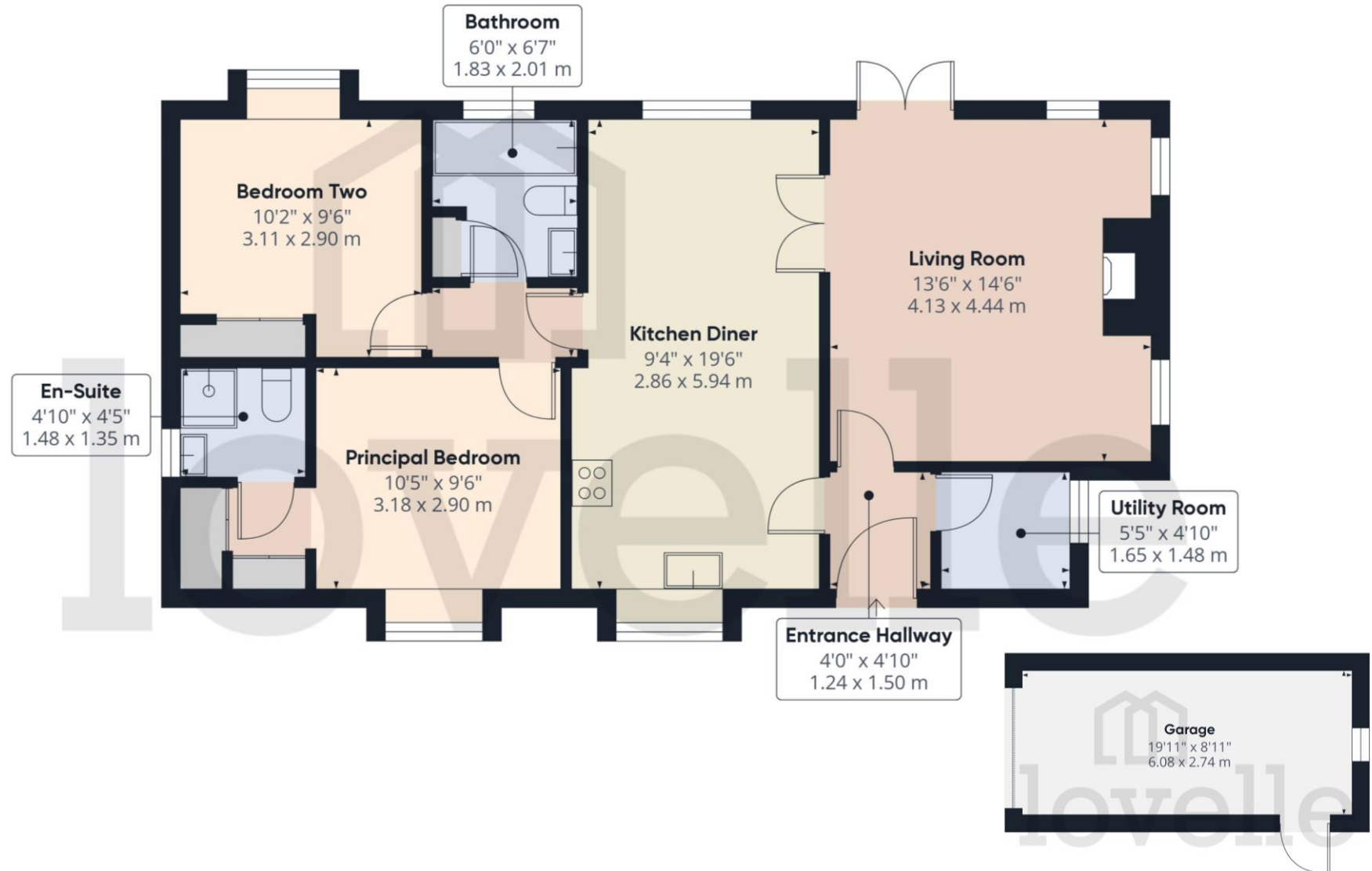

ENTRANCE 1.24m x 1.5m (4'1" x 4'11")
