

ENTRANCE 0.93m x 1.24m (3'1" x 4'1")

Entered through a half glazed UPVC door with sidelights into the porch. Doors to the living room.

LIVING ROOM 3.63m x 4.41m (11'11" x 14'6")

Bright and airy room with a bay window to the front elevation and a further window to the side elevation. Finished with an electric fire sitting on a granite hearth.

KITCHEN 3.36m x 2.56m (11'0" x 8'5")

Range of wall and base units with contrasting work surfaces and tiled splash backs. Freestanding electric cooker with a four ring hob. Composite one and a half bowl sink and drainer with a swan neck mixer tap. Plumbing for a washing machine, dishwasher and space for further under counter appliances.

Window to the front elevation and a half glazed door to the side elevation.

Window to the rear elevation.

BEDROOM TWO 3.37m x 2.73m (11'1" x 9'0")

Window to the side elevation and sliding patio doors to the conservatory.

CONSERVATORY 2.98m x 2.26m (9'10" x 7'5")

Fully double glazed with a polycarbonate roof. Patio doors leading to the rear garden.

SHOWER ROOM 1.67m x 2.04m (5'6" x 6'8")

Three piece suite incorporating a walk in shower, low flush WC and a pedestal wash hand basin with hot and cold water taps. Decorative tiles throughout and a window to the side elevation.
