Nestled in the development is this semi-detached three bedroom home. As you approach this spacious property, you are greeted by a driveway and gated access to the rear garden.

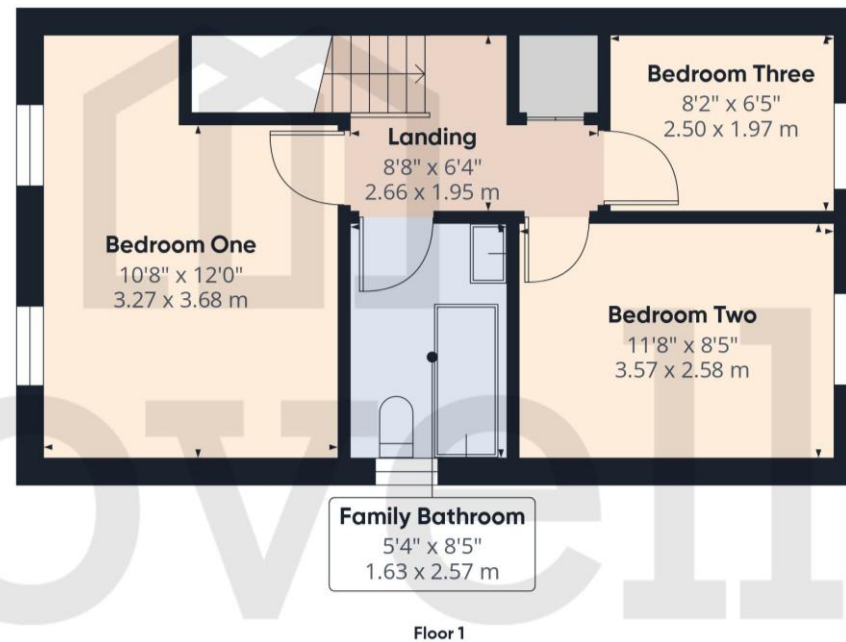
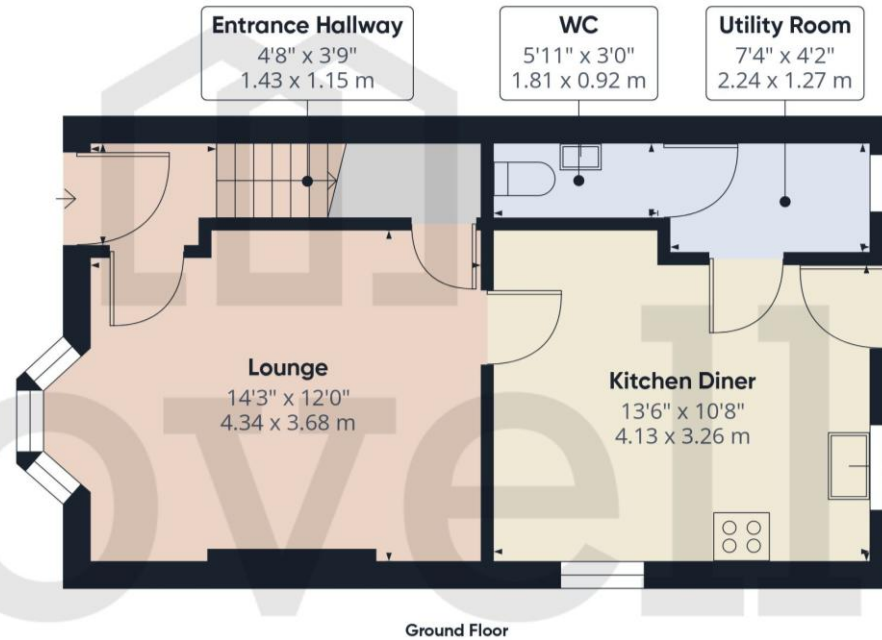

ENTRANCE 1.43m x 1.15m (4'8" x 3'10")

Entered through a composite door into the hallway. Door to the lounge and a staircase to the first floor accommodation.

LOUNGE 4.34m x 3.68m (14'2" x 12'1")

Bright and airy room with a walk-in bay window to the front elevation, that floods the room with light.
