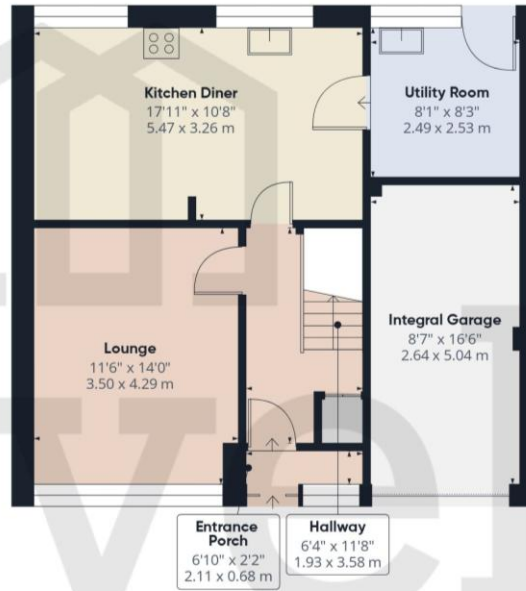
While the first floor accommodation offers three good sized bedrooms, all benefitting from a family bathroom.

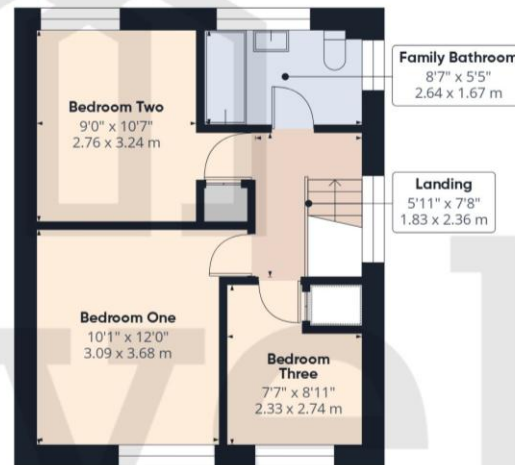

ENTRANCE 1.93m x 3.58m (6'4" x 11'8")

Entered through a porch via a UPVC door into the hallway. Doors to all principal rooms and a staircase to the first floor accommodation.

LOUNGE 3.5m x 4.29m (11'6" x 14'1")

Bright lounge with a "picture" window to the front elevation. Finished with an Adam style fireplace surround housing an electric fire.
