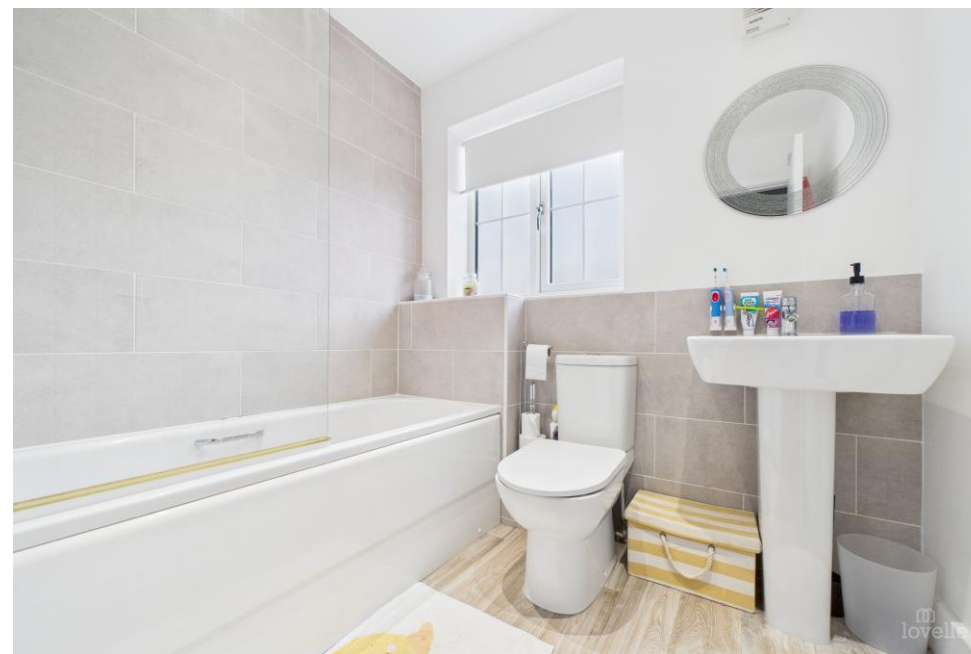

Situated on a quiet cul-de-sac and offering tastefully styled accommodation is this semi-detached home.

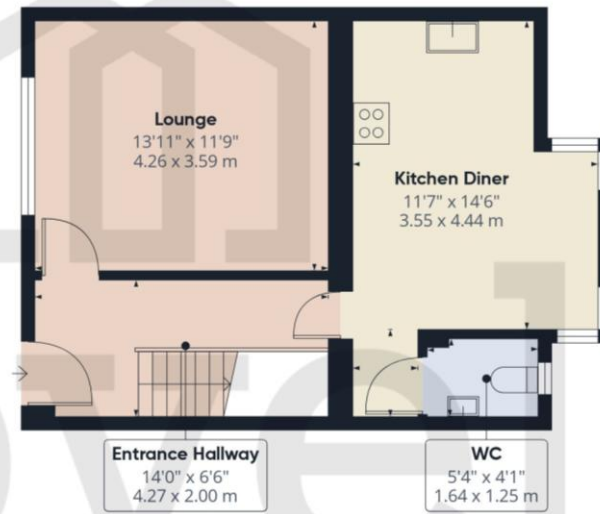

Outside there is a private rear garden, finished with a patio and decking area.

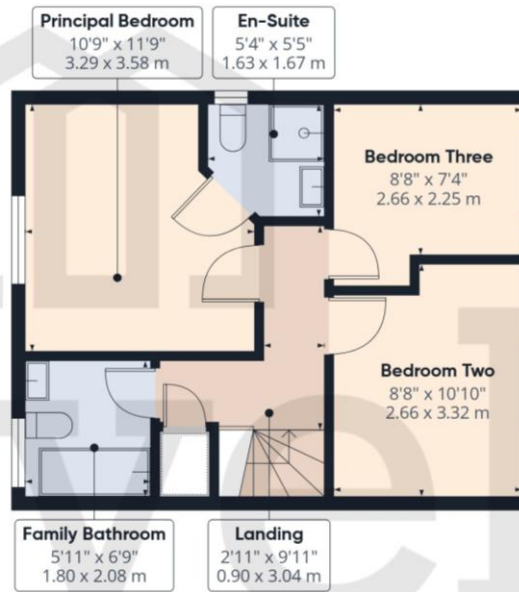

ENTRANCE 4.27m x 2m (14'0" x 6'7")

Entered through a half glazed composite door into the hallway with doors to all principal rooms and a staircase to the first floor accommodation.

LOUNGE 4.26m x 3.59m (14'0" x 11'10")

A bright and airy room with a window to the front elevation.
