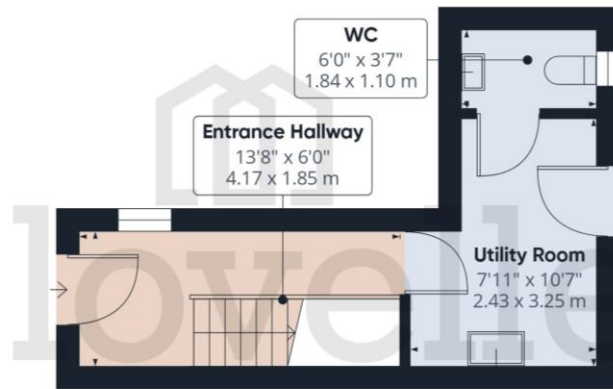

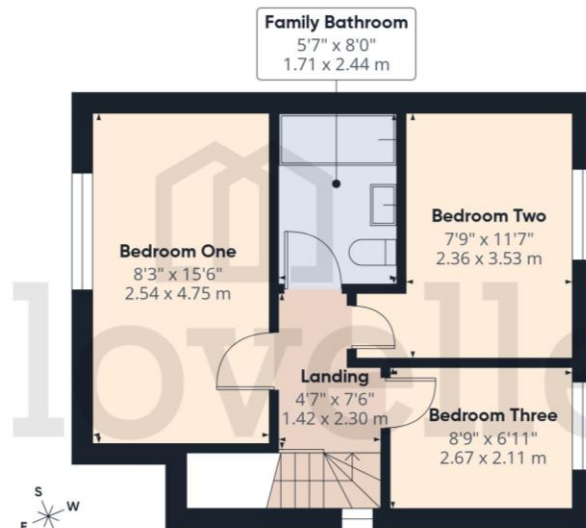
FLOORPLAN
