### Location

The site is located adjacent to Hirwaun Industrial Estate, approximately 4 miles west of Aberdare Town Centre, 17 miles northeast of Swansea and 25 miles northwest of Cardiff.

The A470 dual carriageway gives access to the property from Cardiff and the M4, whilst the A465 provides good links to West Wales as well as the Midlands via the M5 and A40.

Improvement works to the Heads of the Valleys road are ongoing.

## Description

The site comprises a large plot, adjacent to Hirwaun Industrial Estate and Tower Colliery and is predominantly hard core surface, with a concrete access route running along the eastern perimeter.

The site could possibly be sub-divided to accommodate smaller requirements, and could be used for external storage compound use, subject to planning.

The whole site measures 8 acres (3.32 hectares)
