

Location

The restaurant is located on Mill Lane which is one of the premier leisure locations in Cardiff City Centre. In close proximity to the Hayes and the St Davids 2 Shopping Centre, it offers a mix of restaurants and bars geared towards Cardiff's Night life. Notable occupiers in the immediate vicinity include Bills, Ask Italian, Côte Brasserie, Wagamama, Las Iguanas and a mix of local A3 Operators.

Description

The restaurant forms part of a larger property. Access is provided via a communal entrance which is set back from Mill Lane. The foyer area is required for fire escape purposes. The restaurant offers ground floor and first floor areas, with ancillary storage to the first and second floors. The premises will be offered in a partially stripped condition, free of previous tenant's fixtures and fittings. In its current configuration, the front area is reserved for bar and restaurant seating, with kitchen area to the rear. Potential for external table and seating is available on Mill Lane subject to structuring a separate licence agreement with the Local Authority
