The main residence boasts six bedrooms and four bathrooms, with impressive ground floor accommodation that includes a 36ft+ sitting room, ideal for entertaining. There is a recently refitted breakfast kitchen, a separate formal dining room, and a cosy snug with a woodburner, all accessed from an inviting entrance hall featuring original York stone flooring. Additional features include a cloakroom and a cellar.

Set within private south-facing grounds of approximately 1.6 acres, the property is surrounded by feature parkland trees, leading into its own mature grounds which open out to a tree-lined paddock. The paddock benefits from a separate entrance off the adjoining lane.


