## LOCATION

This unit is located in the established commercial area of Fengate on the east side of Peterborough which is a short distance East of Peterborough's ring road (A1139) which provides easy access to the A47, A15 and A1(M).

Peterborough is situated approximately 14 miles to the south east of Stamford, 9 miles south of Market Deeping, 23 miles north of Huntingdon and 23 miles east of Corby.

## DESCRIPTION

The offices are located on the second floor of a three storey office block of steel portal frame construction under a pitched roof. The office suite benefits from laminate flooring, air conditioning, suspended ceiling with recessed lighting, a secure call entry system at the front door and a secure code-lock door to each floor.

## ACCOMMODATION

The premises have been measured in accordance with the RICS code of measuring practice on a net internal floor area basis.




