## **LOCATION**

This property is located in the established Earlstrees Industrial area of Corby and accessed off Brunel Road. Corby is situated 10 miles north of Kettering, 11 miles east of Market Harborough, 8 miles south of Uppingham and 12 miles west of Oundle.

## **DESCRIPTION**

The property comprises a mid terrace warehouse/ industrial unit accessed via roller shutter and personnel entrance door. Male and female w.c's are installed and a ceiling mounted gas space heater. A mezzanine store has been installed to part.

## **ACCOMMODATION**

The premises have been measured in accordance with the RICS code of measuring practice on a gross internal floor area basis.

Ground Floor = 139.5 sqm (1,501 sqft)

First Floor = 85.5 sqm (920 sqft)

Total = 225.0 sqm (2421 sqft)

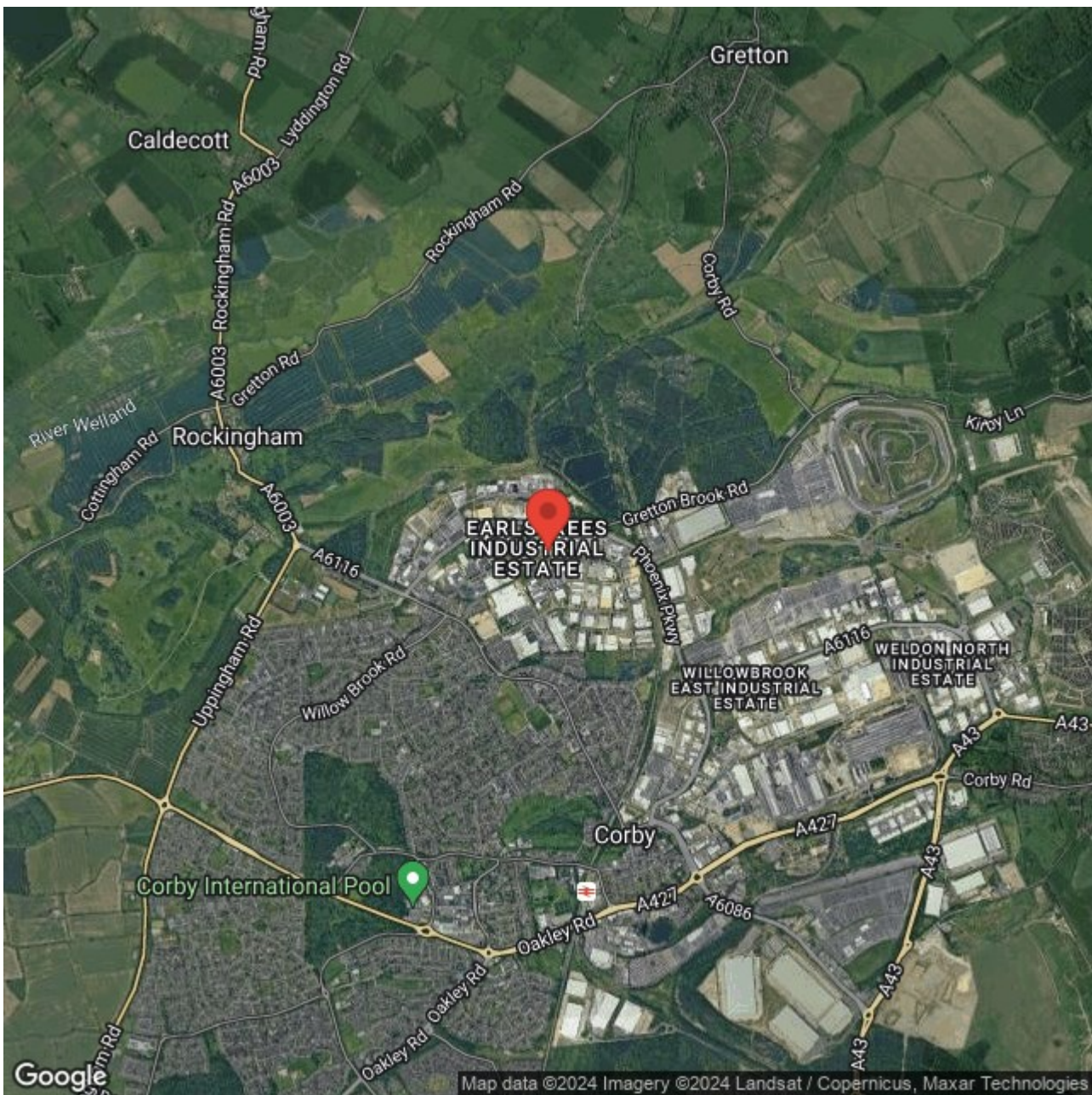
