LOCATION

Axis Park is close to Junction 17 of the A1(M) in a prime commercial location of Orton Southgate. Nearby occupiers within the estate include Yodel, Mears Group, and Steinel UK Ltd.

The Estate has excellent communications being approximately 80 miles north of London, adjacent to the A1(M) and having a complete dual carriageway ring-road system encircling it. There are also fast and frequent rail connections to many parts of the country, with the fastest train journey from King's Cross being 46 minutes.

DESCRIPTION

Two adjoining units, the end of terrace and mid terraced industrial/ warehouse units are of steel frame construction with profiled metal cladding to the side elevations. The units are currently undergoing extensive refurbishment and once completed will comprise of a production area, offices, male and female WC's and two full height electrically operated vehicle loading doors. LED lighting will be installed throughout, the warehouse floor will be painted and a new carpet fitted to the offices. Externally, PV solar panels will be fitted on the roof with the power generated feeding back to the units. There will be brand new dual EV car chargers to the front of the units together with car parking and there is excellent communal parking within the estate.

ACCOMMODATION

The premises have been measured in accordance with the RICS code of measuring practice on an approximate gross internal floor area basis.


