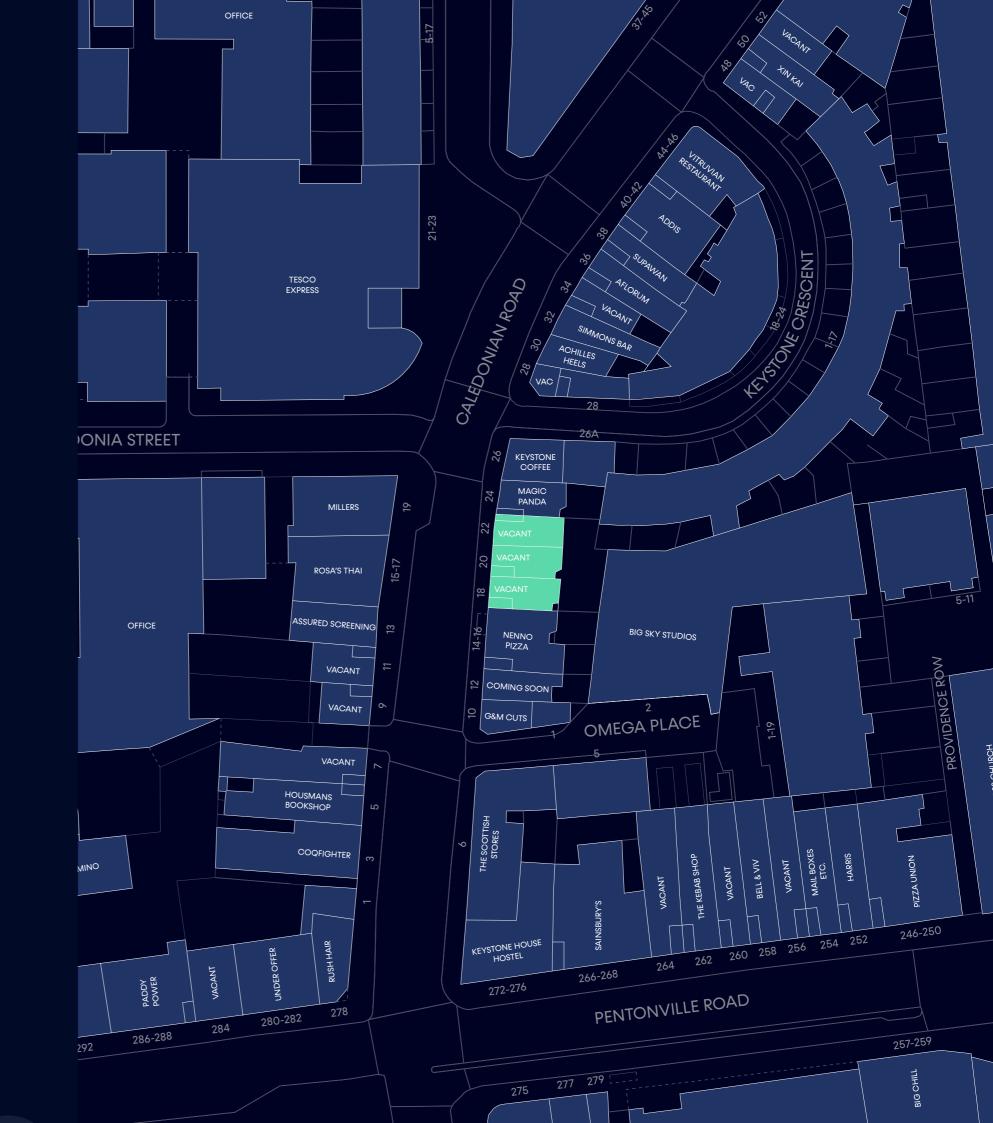






## Caledonian Road
