## LOCATION

Prestwick is located on the west coast of Scotland, approximately 30 miles south-west of Glasgow city centre.

Prestwick International Aerospace Park (PIAP) forms part of the Prestwick Aerospace Campus (Prestwickaerospace.com), which is an established centre of excellence for MRO, aero structures and design engineering. More than 3,500 aerospace related employees are based at the campus – more than 50% of Scotland's aerospace workforce. PIAP is adjacent to Glasgow Prestwick Airport, which could become the UK and western Europe's first Spaceport.

### **TRANSPORT LINKS**

**Road:** 1.5 miles from the A77/M77 dual carriageway, providing access to the Greater Glasgow area

**Train:** Prestwick International Airport station runs 6 trains per hour and is located 1 mile from park.

## **ENTERPRISE AREA**

The park falls within the Prestwick International Aerospace Enterprise Area, Scotland's only Aerospace Enterprise Area. A package of support is available to qualifying businesses, including business rates discounts of up to 100%.

The park has been granted planning permission for aerospace or airport related development consistent with Use Classes 4,5 and 6 of the Town and Country Planning (Use Classes) (Scotland) Order 1997.


All buildings proposed for the sites will be subject to early consultation with Prestwick International Airport Operations staff, to confirm that the design does not affect operational and safety considerations.


### LEGAL FEES
