- Bus Services The "Railway Bridge" bus stop is located approx. 110m south of the site for Bus Services 4, 4A, 16, 16A and 53. The Grenfell Place bus stop is approx. 120m north-west of the site for bus services 4, 4a, 5, 7, 8, 53, 127, 238 and 239.
