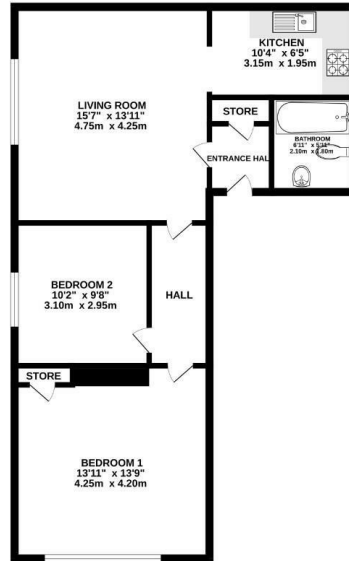

GROUND FLOOR

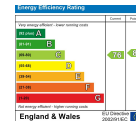
