Centrally located in the main shopping precinct of Coatbridge, Taste of China sits in a pedestrianised area surrounded by a mixture of licence, retail and mixed use buildings. A stone built building the restaurant itself can be found on the upper floor with customer access from the front whilst deliveries and staff are able to access the property at the rear, where parking is also available.



#### Location

Coatbridge is a town in North Lanarkshire, Scotland, about 8  $^{1/2}$  miles east of Glasgow City Centre, set in the Central Lowlands.

Along with neighbouring town Airdrie, Coatbridge forms the area known as the Monklands (population approximately 90,000 including outlying settlements). Monklands is often considered to be part of the Greater Glasgow urban area although officially, they have not been included in population figures since 2016 due to small gaps between the Monklands and Glasgow built-up areas.

#### **Internal Details**

Access through the front door, located on the street, takes you up a flight of stairs to the main restaurant area. Currently, the restaurant is not operating with the main focus being the takeaway business. The restaurant itself can hold up to 80 covers once fully operational.

To the rear is a fully fitted commercial kitchen.
